**BRONZE PELICAN AWARD**

The Diocese of Baton Rouge's Catholic Committee on Scouting uses the following guidelines for the selection of the recipients of the Bronze Pelican Award. The requirements for the Bronze Pelican Award are less stringent than those for the St. George Medal.

The Catholic Committee on Scouting for the Diocese of Baton Rouge provides the Bronze Pelican Award to Catholic and non-Catholic men and women as recognition of their efforts in contributing directly to the spiritual nourishment of Catholic boys and girls in the Scouting movement.

The Pelican has been used as a liturgical symbol since the early days of Christianity. It denotes the tender care of the young by the parent and of the Church. As such it is an appropriate symbol for those who give of themselves to the development of boys and girls in their formation as Christian leaders.
