Your signature binds you to the following rules and regulations:

1. I agree to check in and set up between 7:30-10:00 AM on Saturday, August 28. I will be present in my booth during Car Show hours, and understand that early closing and/or tear down is not permitted.
2. I understand that I am 100% responsible for my booth and all property including exhibited and personal property, set up and tear down, sales, and trash disposal. I release The Potato Days Festival volunteers and staff from all responsibility for any loss, damage or theft of my property.
3. I understand that I am responsible for providing chairs, tables, and canopy.
4. I agree not to use or have in my possession illegal drugs and alcohol while in the Car Show area. I also understand that pets are not allowed in my booth during the show. I will not disturb or harass other exhibitors in any way.
- 5. I understand that electricity, running water and WIFI are NOT available in the Car Show area.** Generators are allowed ONLY if they are quiet and odor-free. Complaints from fellow vendors or visitors will result in the immediate removal of the generator.
6. Only one vendor per booth space rented. Signage for each booth is limited to the group or business name only.
7. I agree that all income derived from the sales of my products are entirely mine, and I am solely responsible for collecting and submitting any sales taxes to the State of Minnesota.
9. I agree that Potato Days Festival reserves the right to revoke or refuse to grant space at any time, without recourse by the participant. The Potato Days Festival shall not be liable to anyone for this action.
10. I understand that no swap space will be granted to those wishing to express religious, moral, or political opinions. Only materials approved by the Potato Days Festival will be allowed. Displaying information that has not been approved by the Potato Days Festival will result in expulsion from the event without recourse or refund.

I hereby waive and release the Potato Days Festival, the City of Barnesville, employees, sponsors, organizers, and officials from any and all liability for injuries, damage, or theft occurred during the Potato Days Festival on August 28, 2021.
