

# 2018 Mason County Fair Campground Agreement

## BEHIND STAGE AREA

To All Campers:

This year contracts are due May 30, 2018. You may keep the first page for your own files and send in the second only. Please send in a deposit or \$100.00. Camping has been raised to \$175.00 with out sewer and \$225.00 with sewer. If you need more copies for friends or know of someone that would like to camp, please fell free to make a copy or call 304-593-0131/304-812-7918. NO refunds on deposits. If with a group, PLEASE send all papers in together and write who you will be camping with. It helps to see everyone is together.

**All persons on the fairgrounds, including campground area, must have a wrist band on at all times.**

1. I understand that all persons staying in or on my campsite must have a wrist band and that any director of the Mason Co Fair Board may request to view the wrist band at any time. Anyone caught without a wrist band for the day will be removed from the grounds and must purchase a ticket to re-enter the grounds.
2. **All vehicles must be removed from the campground by 6:00 am Monday, August 6, 2018. If this rule is violated all camping privileges will be revoked. You will be asked to leave. Vehicles may reenter the campground on Saturday August 11, 2018 after 11:30 pm.**
3. **NO** alcoholic beverages or controlled substances permitted on fairgrounds. No smoking on fairgrounds.
4. Curfew is 12:00 pm (midnight) or 45 minutes after the end of the last event in the area.
5. An Adult must stay with any minor under the age of 18.
6. Each camper is responsible for their waste disposal and litter control.
7. Pets must be kept in camping area. No pets allowed in fair area. Please be considerate of other campers if you have a pet. Please dispose of the waste appropriately.
8. Electrical problems of any kind such as breakers kicking out or loss of power must be reported to the camp committee. Only licensed fair electricians are allowed to fix electrical problems. **NO EXCEPTIONS!!** Do not attempt to fix your electric. This is a safety hazard. All extension cords must meet electricians and/or fire marshal's specifications and/or recommendations. You may be asked to change your cord if it is found to be inferior at your own expense. Electricians have the right to inspect all fans, air conditioners, and electrical appliances. Power outages are out of the fairgrounds control. Should a power outage occur, the committee will do everything possible to get it restored as quickly as possible. The fair board is not responsible for any damages done to your camper or RV unit during a power outage of any kind.
9. No open fires or campfires of any kind are prohibited. Anyone caught with a fire on their campsites will be evicted immediately and future camping privileges revoked permanently.
10. ATV's, UTV's and/or Golf carts are prohibited. Only members of the fair board and officers of Fair will be allowed to bring ATV or Golf Carts to the fairgrounds. All others will be impounded and asked to remove immediately.
11. **NO TOLERANCE POLICY** – Verbal abuse, physical abuse, or harassment toward directors, judges, ring stewards, superintendents, employees, WVU Extension Staff, junior fair members, club advisors or volunteers of the Mason Co Fair will not be tolerated. You will be escorted from the fairgrounds, premiums forfeited, and upon The Mason Co Fair Board Directors decision, your family members may not be able to exhibit at the Mason Co Fair for a period of time indicated by the decision based on the severity of the situation.

**Please complete the agreement and enclose a \$100 non-refundable deposit on or before May 30, 2018. The remaining camping fee will be due upon parking the camper on August 2, 2018.**
