1) I hereby acknowledge that the risk of injury from the use of firearms and other known and unknown events and activities and/or the use of the firearms-related structures, premises, equipment, and all other real and personal property whether owned by NPTSA or others is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,

2) I acknowledge and agree that the use of firearms and/or related equipment by myself or others on the premises comprising NPTSA, or otherwise, are inherently dangerous and high-risk activities whether such firearms or other equipment is discharged by myself or others; and

3) I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF OTHERS, and assume full responsibility for my participation; and,

If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest NPTSA officer immediately; and,

5) I fully understand and agree that this Release and Waiver shall be held in the files of the NPTSA, and shall be considered ongoing for all future uses of NPTSA assets, equipment, or facilities.
