

Director of Strategic Programmes Report - Alison Scowcroft

COVID-19 continued support

CHL continued the theme of support for commissioners and community pharmacies around the COVID-19 pandemic in 2021/22 through the support offered to 2 local authorities in setting up and ensuring access to lateral flow testing through community pharmacy.

Community Pharmacy priorities

One of the key priorities identified for community pharmacy in 2021/22 was the implementation and deployment of the new nationally commissioned advanced services; GP CPCS in particular was a substantial project that CHL managed in the year. We collaborated with Bolton and GM LPCs, GMHSCP and general practice colleagues to prepare a deployment blueprint and plan, supporting resources, materials, and processes. We supported the system engagement of GP CPCS through a series of governance forums and ensured engagement across the 10 GM localities and 67 GM PCNs. CHL project managed the implementation and deployment across the 423 GM practices.

Vaccination training was another priority in the year, and CHL partnered with ECG and PharmaDoctor to deliver an attractive training offer for pharmacists across GM and Cheshire & Merseyside, liaising with Community Pharmacy Cheshire & Wirral. The training sessions had good uptake, and the content received positive feedback from all delegates.

As we moved into a supposed 'post-pandemic' era, some of the work delayed in 2020/21 was restarted, particularly the relaunch of the GM commissioning Inhaler Technique Service. CHL updated the service specification and PharmOutcomes modules, performed an Expression of Interest process to relaunch the service with 67 newly commissioned pharmacies (1 per PCN) and then delivered training and engagement events. A significant change to the service delivery was the provision of the service by pharmacy technicians; CHL prepared additional resources for the technicians being accredited to deliver the service.

Supporting community pharmacy with locally commissioned services

The commissioners whom CHL partners with to support the provision of locally commissioned services renewed their SLAs with CHL this year, confirming the value they derive from our support.

The PGDs for sexual health services were updated in several localities in GM in 21/22. CHL ensured that the PharmOutcomes modules were updated in line with the change to the PGDs and also that the modules were as straight forward to use for pharmacists as possible, thus ensuring their compliance with all aspects of the service specifications.

Pharmacy Integration Fund Pilot

A Signarold

The CURE pilot continued in Oldham into 2021/22, with good uptake of the service by the referring hospital and conversion and quit rates achieved by the participating community pharmacies in line with those results achieved by the locally commissioned specialist service. A number of patient case studies were prepared, and one was published on the NHS England website to publicise the great work delivered in Oldham. NHSE evaluated the Oldham pilot results, and a decision was taken in early 2022 to rollout the service nationally from March 2022. This decision was based purely on the results of the service delivered in Oldham.
