- Sign up to receive the Governor's press releases. Some will be more interesting than others. - Check out and become familiar with the General Assembly website. You can use it to find out who your reps are, track bills, find committee meeting times, etc. http://virginiageneralassembly.gov/
- 3) Determine which Delegate and Senator represents you. You will be encouraged to go to see your legislator and/or aide during your Senior Seminar visit in January. <a href="http://whosmy.virginiageneralassembly.gov/">http://whosmy.virginiageneralassembly.gov/</a>
  And, find out more information about your representatives committees, personal information, etc. This is available on the GA website.
- 4) Review the information at the following link on how a bill becomes a law http://capclass.virginiageneralassembly.gov/Middle/HowABill/HowABill.html (Or sing the School House Rock jingle to yourself.)
- 5) Check out SCHEV's list of higher education-related bills. Up there now are the lists from last year and are worth getting familiar with as many similar bills are likely to be introduced. They will add bills for the 2019 Session as it gets closer, so check back in December. We will discuss a number of these bills in January. - 6) The Virginia Department of Planning and Budget (the Governor's budget agency), and the House Appropriations and Senate Finance committees (the General Assembly "money committees") regularly post information. Check out their most recent documents to get a sense of current budget situation. We will discuss the status of the budget in January.

#### Extra Credit:

Go to the General Assembly website (<a href="http://virginiageneralassembly.gov/">http://virginiageneralassembly.gov/</a>). Go to Session Tracking (bottom middle) and select "2018 Bills and Resolutions." This will give you an option of putting in a bill number. Using this, track a few bills from SCHEV's list through last session to see how they fared, how they were changed, and which committees they went to.
