Secretary of Education Nominee is Cause for Concern

President-Elect Donald Trump has recently tagged Betsy DeVos as the next Secretary of Education. Betsy DeVos is a strong backer of charter schools and vouchers to private institutions. It is clear that the policy of this administration will focus on privatization and the defunding of public schools. DeVos is extremely conservative and the former chair of the Michigan Republican Party. Michigan has been one of the states that has most aggressively moved towards school choice with very poor results. Unlike in New York State, Michigan allows "for profit" charter schools. It is easy to assume that the bottom line is at least as important as the line at graduation.



DeVos is considered an enemy to public education. She is the daughter-in-law of Amway founder, Richard DeVos and uses her connection to other billionaires to help drive the charter school and voucher agenda. This is the epitome of letting the kid run the candy shop. Her interests are contrarian to the foundation of public education that has served this country well, since its inception. DeVos has never attended public school. She has never worked in a public school, ran one and none of her children went to public schools. She has used her wealth to lobby against campaign finance reform and attacking labor laws. DeVos is not only unqualified, she is looking to turn public education over to the private sector.

How has Betsy DeVos impacted the education system in Michigan? Eighty percent of charter schools in Michigan are for profit, privately run and privately managed. Very often, these schools are worse than the public schools that the students are leaving. The charter schools have fewer students with disabilities and fewer English as a New Language learners. Additionally, students can be removed from the charter school system for disciplinary reasons and return to the public school system. Also proposed in Michigan is a school voucher program. Families would be given a voucher for \$4,000 - \$8,000 and told they can attend any school they choose, charter or public, religious or community. This violates the law of separation of church and state. Charter schools were originally intended to function as a small scale laboratory for cutting edge educational practices. Unfortunately, this movement has been taken over by opportunists looking to create massive charter for-profit networks.

Senate hearings will be held as part of the approval process beginning January 11th. Expect the NEA, AFT and friends of public education in the Senate to expose Betsy DeVos as the antithesis of an advocate for public education.

It is difficult to predict what to expect in the upcoming years. President-Elect Trump will attempt to push a pro school choice initiative and attempt to decrease the influence over the federal government's role in education. The new ESSA Law (Every Student Succeeds Act) has been revised to assure that the billions of dollars that flow through the states and then local school districts is distributed to assist the most impoverished areas. Time will tell if that actually occurs. Also, if DeVos is approved, AFT and NEA will opposes as much of the Trump agenda as possible.

Happy New Year to all of the WGTA. Our Superintendent's Liaison Committee (SLC) presented the following issues to the Superintendent: the need for more support for students with emotional concerns by way of a Social worker at WGMS, school psychologist at CMS and more counselor support at the elementary level. We have also discussed the need for the district to support students whose families are not financially sound. The financial struggle that these families are going through has an effect on a child's ability to function well in school.

We continue to discuss the substitute situation and hash out the problems and successes seen with the new service provided by BOCES. The more elaborate versions of these minutes are given and distributed by your representatives on the SLC. If you have any more issues that cannot be addressed at the Principal liaison, please add send them to us when the next all-call for agenda items goes out to staff.

Directing Council Teaching Center Update

Eight Collegial Circles have been approved and three Action Research Project have been approved. There was an approval of \$400 for Professional Development for a speaker on Mental Health. There was a district request for Student Teachers from Syracuse University. We are in need for a representative on the council from the high school. WGTA initiated fundraising for two medical research endeavors, The Carol Baldwin Breast Cancer Research and the Leukemia and Lymphoma Society. Your contributions will go towards finding cures and ensuring access to treatments for breast cancer, leukemia, lymphoma, Hodgkin's disease and myeloma, as well as to improve the quality of life of patients and their families. Between the two fundraisers, WGTA contributed \$637.00. Your generous response will support cancer patients and continued research for a cure. We want to thank everyone that participated.

There has been discussion of changing the direction of WGTA's philanthropic approach. We recognize that there is a greater local need for support within our own community. As such, we have coordinated with West Genesee School District to gather and disperse items that will positively impact students, staff and families in the West Genesee community. The WGTA, along with other WG staff and students, collected non-perishable food, clothing, hygiene and other items. These items were then sorted by HS Student Council students and assembled into care kits. Over 75 care kits were made and distributed back to the schools. Additionally, each nurse's office at the elementary schools received a stockpile of assorted hygiene items that they will dispense throughout the year as needed.

The success of our local outreach this year, has reinforced our shift from raising monies for The Carol Baldwin Breast Cancer Research and The Leukemia and Lymphoma Society, towards a more local focus that will meet the needs of our own community. Next year, in lieu of fundraising for cancer research, WGTA will coordinate with West Genesee School District to conduct another "annual" fundraiser drive for our neediest community members. In addition, we may provide monetary donations on a case by case, pressing need basis.

TEN QUESTIONS FOR NEWS DETECTION


Use the questions below to assess the likelihood that a piece of information is fake news. The more red flags you circle, the more skeptical you should be!



1. Gauge your emotional reaction: Is it strong? Are you angry? Are you intensely hoping that the information turns out to be true? False? YES I NO



- 2. Reflect on how you encountered this. Was it promoted on a website? Did it show up in a social media feed? Was it sent to you by someone you know?
- 3. Consider the headline or main message:
 - a. Does it use excessive punctuation(!!) or ALL CAPS for emphasis? VES I NO
 - b. Does it make a claim about containing a secret or telling you something that "the media" doesn't want you to know? VES | NO
 - c. Don't stop at the headline! Keep exploring.
- 4. Is this information designed for easy sharing, like a meme? INO
- 5. Consider the source of the information:
 - a. Is it a well-known source? YES I NO ...
 - b. Is there a byline (an author's name) attached to this piece? VES I NO
 - Go to the website's "About" section: Does the site describe itself as a "fantasy news" or "satirical news" site? YES I NO
 - Does the person or organization that produced the information have any editorial standards? VES I NO
 - Does the "contact us" section include an email address that matches the domain (not a Gmail or Yahoo email address)? YES I NO
 - f. Does a quick search for the name of the website raise any suspicions?
- 6. Does the example you're evaluating have a current date on it? YES I NO ...
- 7. Does the example cite a variety of sources, including official and expert sources? Does the information this example provides appear in reports from (other) news outlets?
- 8. Does the example hyperlink to other quality sources? In other words, they haven't been altered or taken from another context? YES | NO



10. If you searched for this example on a fact-checking site such as Snopes.com, FactCheck.org or PolitiFact.com, is there a fact-check that labels it as less than true?






- It is easy to clone an existing website and create fake tweets to fool people.
