Hand delivered artwork may be picked up Aug. 31 to Sept. 2nd between 11 and 4pm.

September 5,

All shipped works returned using prepaid shipping labels. Prize and sale money distributed.

AVENUE WEST GALLERY RULES & REGULATIONS

ENTRY FEE: \$20 for first entry, \$10 for each thereafter— limit 5 entries. All entries exhibited will be for sale and must be priced.

ELIGIBILITY: This exhibit is open to all artists in the category of PAINTING, which includes oil, watercolor, acrylic, pastel and mixed media. Photography includes both film and digital. Work must be the original creations and compositions of the artist submitting it. Copying a painting or photograph by another artist with a few details changed is not considered an original work. Artwork must have been created within the last five years. Student work cannot be submitted that has been done in class or with the help of an instructor. Current members of Avenue West Gallery are not eligible to enter this exhibition.

DIGITAL & PHOTO ENTRIES: Each artist may submit up to 5 entries. Digital entry files must be in JPEG format on a CD (compact disc). More than one entry may be on your CD. The image must be oriented correctly (vertical or horizontal) with image only; no frames, etc. Title the image file as follows: 1. Artist's first initial, 2. Artist's last name, 3. First two words of the title followed by 4. .jpg. Example: JSmith WoodScene.jpg. Label your CD using a permanent marker, with your name and phone number. The CD will not be returned. **DO NOT SEND ORIGINALS. Mail your entries, with CD and fees to Dian Zahner; 5323 W. Woodview Ct., Spokane, WA 99208** . Emailed entries can be sent to Avenuestwestgallery@gmail.com . Send payment for email entries through Paypal at the same email address. All entries must be received **on or before May 31st.**

JURYING: Selections will be made from digital imaging and from email submissions. No withdrawals or substitutions will be selected after a work is juried into the show

ACCEPTANCE & NOTIFICATION: All digital entries, including fees and images, must be received no later than **Wed. May 31st**. Notification will be emailed to each entrant no later than **Saturday, June 23rd** indicating which works were accepted or declined. Avenue West Gallery is not responsible for lost, stolen, or misdirected entries. If an artist whose work has been accepted into the show fails to send that work for the exhibition, that artist will not be permitted to enter any future AWG exhibits.

SIZE REQUIREMENTS OF ENTRIES: Work, including frame, should be no more than 36 inches on its longest side. All work must be framed and ready to hang on wire hangers. **No sawtooth or alligator hangers, please!** You must have an identification card on the back of each piece with your name, phone number, title of piece, and sales price.

DELIVERY OF ACCEPTED WORK: All accepted art work must be received at **Avenue West Gallery, 907 W. Boone, Ste. B, Spokane WA 99201 between July 28th & July 29th**. Gallery hours are Tues-Sat. 11-4 . If works are shipped, they must be shipped with return prepaid postage included.

RETURN OF WORK: Unsold shipped work will be returned to the artist at the end of the exhibit beginning the week of **Sept 5th** and must have prepaid return postage included . **Hand delivered**

work must be picked up from the gallery August 31st -Sept. 2nd between the hours of 11 am and 4pm.

LIABILITY: Avenue West Gallery DOES NOT carry insurance on individual works. If you wish to have your work insured, you must make your own arrangements.

ARTWORK SALES: If a piece is sold during the duration of the exhibit, Avenue West Gallery will retain 30% of the sale price, excluding sales tax. State sales tax of 8.7% will be added onto the sale price at the time of sale. Sales will be processed through Avenue West Gallery and checks for sales and prize money will be mailed to all artists at the conclusion of the exhibition.
