The SAGA continues... It began in mid-March: the 87' plus vessel, the Gallant lady, FWC case # FWC23ON0042411. A violation notice was served on

June 11th. Seven months (Oct. 16th) later she sits on the bottom listing at about 45 degrees with only the lines and pilings holding it from rolling over.

During the past several months I have made numerous attempts to receive a response or an update of the status (via text, voice mail and email) from the officers of the FWC managing this case, Officers Favrot and Peppel. In mid-August I left a message for the Regional Director, Dr. Thomas Reinert. He was kind enough to call me back the same day and follow up the next. At last communication with Dr. Reinert on Oct. 18th, the status was the same; the removal is out for bids. He vowed to contact me with any change. Maybe a Christmas present.



Riverland Road Speedway Update


On October 25, 2021, the City's consultant Kimley-Horn held a public meeting to show residents what traffic calming measures were feasible along Riverland Road (and sadly no, traffic circles were not feasible due to Right-of-Way constraints). Fast forward to today, the final design plans were submitted by the City to Broward County for review as a large portion of Riverland Road is still under their jurisdiction. The City is still awaiting review comments back.

What traffic calming final plans are you talking about? The plans that were not shared with the residents prior to being finalized, is what I am talking about. If you are interested to see if a raised intersection is at the end of your street or has impacts to your driveway, please attend the next LICIA General Meeting in

November or contact the City's Transportation and Mobility Dept.

As far as the actual construction funding, the budget that the City Commission just adopted included \$1 million in FY27 for construction. The City also submitted the project for State Transportation Appropriations on a sooner timeline with our representatives. So far, they have not been successful in lobbying for funding, but have again submitted for consideration in the next legislative session. In addition, the City previously submitted the project to the County Transportation Surtax Program, however it did not rank high enough for any funding (remember it was only a "Penny," but in reality, it was a 1% sales tax increase disguised in sheep's clothing). Bottom line, the funding has now been kicked down the road until 2027, if at all.

Remember this and the failed purchase of the yacht club when elections come around.

Getting to know

In our last edition of the LICIA newsletter, we mentioned the close relationship between the City of Fort Lauderdale Code Enhancement Department and our association. For

this edition, we wanted to get to know Marco Aguilera on a more personal basis.

Born in Aventura and raised in Hollywood, Marco is one of those rare native South Floridians we happen to come across from time to time. Growing up he was an active and enthusiastic Boy Scout and thoroughly enjoyed doing anything outdoors, which he continues to do with his children. One of his favorite things to do in his private time is camping and he has pretty much stayed at all thecampgrounds in Florida. Like many of us, boating and fishing are also up there on his favorite things to do.

After finishing high-school, Marco started working for the City of Sunny Isles, in a program that offered outings & excursions to senior citizens of Sunny Isles. It sounds very simple, but when taking all the details into consideration, this meant organizing everything from pick-up, transportation, activities, food, drinks, scheduling medications, rest stops, and then transfer back to Sunny Isles. He was also instrumental in planning big budget events in Sunny Isles, and really enjoyed being part of all the fun times with the residents.

With time though, his focus and wish were to be part of law enforcement. He took a position at the City of Pembroke Pines as a Police Service Aide, with the intention to starting training to be a law enforcement officer. However, the City of Pembroke Pines saw his personality and introduced him to the Code Enforcement Depart-

ment. This was something completely new to him. He had never heard of the department, however the City offered to pay for his certification. He agreed and began his career in code enforcement. As he mentioned, this still falls along the lines of enforcement, but without having to carry a gun or chase after criminals. "I actually get to see the positive results of my actions." Whether commercial or residential properties, I can see the result of my work, thereby helping to improve neighborhoods."

This new position took him back to the City of Sunny Isles, where he looked forward to further career development. Unfortu-

nately, that was short lived, as Sunny Isles consists of only one major road and small side streets. The territory was small, and there were challenges with city politics, lawyers on speed-dial, etc. As luck would have it within a year, the City of Fort Lauderdale Code Enhancement Department had openings. Marco applied, was hired, and Lauderdale Isles became one of his assigned neighborhoods. With a larger territory, a lot of diversity and a city that lets the inspectors do their job, he feels he has found his niche.

Lauderdale Isles has benefited greatly due to his dedication and close work with our community and LICIA. He is extremely approachable, responsive, and very dedicated to his job, and overall, one of the nicest people you will meet. AIRPORT NOISE UPDATE

Noise complaints are down...way down. Prior to the implementation of Metroplex, Lauderdale Isles filed more airport noise complaints than the rest of the county combined.

Eighty percent of the time, plane departures at FLL are to the east, over the ocean, and we hear no noise on take offs. However, when winds are from the west and with planes departing into the wind, Lauderdale Isles experiences airport noise. But the noise levels now are significantly less, thanks to the Metroplex RNAV procedures that keep most departures south of the neighborhood. In fact, BCAD's consultant tracks departures and approximately 70% of west take-offs are on RNAV. This number should continue to improve with time. "RNAV to DREDS" was our rallying cry during the Metroplex study. (For you new neighbors, DREDS is the way-point the planes use that keeps them south of us.)

With Metroplex as originally proposed, planes would have flown so close to our neighborhood that noise would have continued to be a major issue. The LICIA Airport Noise Committee worked with then-Commissioner Ben Sorensen and the country's preeminent airport noise law firm during Metroplex design. For the first

time ever, our team was able to convince the FAA to alter their procedures without the need to go to court. In August, 2021, RNAV to DREDS became a reality, and noise decreased significantly for us.

To see how noise complaint numbers have decreased dramatically since Metroplex: in 2019 there were a total of 52,413 noise complaints filed by the entire county, and 44,541 of those came from Lauderdale Isles. But for January thru August of this year, only 204 complaints were filed from the Isles.

Noise complaint totals confirm that airport noise is significantly less for us now, compared to the days before Metroplex.

Note how East Fort Lauderdale and East Hollywood have higher numbers. This is because on eastward departures out over the ocean, the planes turn back toward the coast immediately and fly directly over those areas before attaining significant altitude. Interestingly, East Fort Lauderdale, East Hollywood, and Plantation do not have members on the BCAD Airport Noise Abatement Committee. Lauderdale Isles has two very active members on that committee who have served on it since 2014.

Your Airport Noise Committee remains committed to ensuring that the FAA and the Airport continue to fine-tune the Metroplex procedures to lessen airport noise as much as possible.

Maybe someday no airport noise complaints?

Community Center Update

As you may already be aware, by reading the last newsletter and attending the last General Meeting, the former beloved Yacht Club was sold to a private owner despite the City submitting an imperfect offer. We welcome our new neighbors on Whale Harbor Lane and wish them success. Gratefully, the story doesn't end there and the Lauderdale Isles Neighborhood will be pursuing a new Community Center at the Riverland Woods Park.

The City's Parks Bond included funding for land acquisition including the former yacht club in anticipation that the current owner would sell to the City. The LICIA Board has requested to our District Commissioner Warren Sturman that that money be reallocated towards the construction of a new Lauderdale Isles Community Center. Myself and Geoff Rames. LICIA V.P., have attended numerous meetings with the City's Architectural Consultant AECOM and the

City's Parks & Recreation Director to verify that the project funding and concept were feasible.

On October 17, 2023, our Commissioner brought up the issue at the City Conference Meeting to inform his colleagues of the recent events. The resulting discussion was that the City Manager would be bring the new Community Center back to the Commission for further information.

What does all this mean? I have managed many community centers in the past few years and I can tell you we are at the beginning of a long process that needs constant monitoring to ensure timely progress. The process will start with the City hiring a consultant to develop concepts, final designs and subsequently obtain bids for construction. We would like to get a head start by confirming with the neighborhood what your thoughts are and how you would like to use the facility. If you have any interest for further information or would like to provide feedback, please attend the next LICIA General Meeting on November 16th at 7:00 PM.

Another Invader: The Saddleback Caterpillar

This tiny varmint has been spotted in the Isles. Being informed about this cute creature may save you from a painful sting. It is about a 1/4" but its sting is agonizing and the pain may last more than 24 hours.

The picture to the right is of one found (one of several) on a resident's green yard waste bin. It is

the larva of a species of moth native to North America and favors the warmer climates.

The saddleback caterpillar has one of the strongest stings and is usually found in so many of decorative plants landscapers and gardeners (novice and professional) are most at risk. The spines that

cover the caterpillar, when broken, discharge a toxin that will irritate the victim and will likely cause an acute rash. The vivid coloring represents their degree of toxicity.

There is a long list (50+) of host plants that are plentiful in South Florida and include various palms, codiaeum (commonly known as Croton), Flamingo Flower, Bird of Para-
