3. Street Dept. Employee Criteria

It was moved by Councilman Joseph and seconded by Councilman Anderson to approve suspending the requirement of a high school diploma for the hiring with Street Department only until further notice; all other departments will remain the same. **All in favor, motion approved.**

4. Curfew Hours

After some discussion of the curfew hours, Councilwoman Lemoine recommended that the curfew changes from 11:00 PM to 5:00 AM for adults and businesses and the curfew for minors will remain the same; it was seconded by Councilman Riggs. All in favor, motion carried.
