• **Re-evaluation Rule 89(v)**

The fee for re-evaluation shall be Rs. 260/ per script, a particular candidate who applies for concession will be shown his/her answer script(s) on payment of Rs. 65/- per script (non-refundable). If the candidate is satisfied on seeing his/her paper(s) and decides not to opt for the concession of re-evaluation the case will be treated as closed. If on seeing his/her answer sheet(s) he/she decides to opt for re-evaluation, he/she shall be asked to deposit the remaining fee i.e., Rs 260/ per script and thereafter, the action will be taken as provided in the rules relating to the scheme.

• **Re-evaluation Rule 92(i)**

The result declared under the scheme of re-evaluation shall be binding on the students who will be required to submit an affidavit duly sworn before 1st class Magistrate or a public notary or an oath commissioner to the effect that the result of the re-evaluation shall be final and binding upon him/her.

No further re-assessment shall be allowed after the award is received from the examiner who evaluated the answer sheet(s) on re-evaluation.
