### IMPLEMENTATION TIMELINE

### **Preliminary report**

Not later than 180 days after the date of enactment of the JOM Modernization Act, the Secretary shall publish a preliminary report describing the number of eligible Indian students served or potentially served by each eligible entity, using the most applicable and accurate data (as determined by the Secretary in consultation with eligible entities) from the fiscal year preceding the fiscal vear for which the initial determination is made.

### **Comment period**

After publishing the preliminary report under clause (i) in accordance with clause (ii), the Secretary shall establish a 60-day comment period to gain feedback about the preliminary report from eligible entities, which the Secretary shall take into consideration in preparing the final report.

### **Final report**

Not later than 120 days after concluding the consultation described in clause (iii), the Secretary shall publish a final report on the initial determination of the number of eligible Indian students served or potentially served by each eligible entity, including justification for not including any feedback gained during such consultation.

### Rulemaking

Not later than 1 year after the date of enactment of the JOM Modernization Act, the Secretary, acting through the Director of the Bureau of Indian Education, shall undertake and complete rulemaking process.

### **Subsequent academic years**

For each academic year following the fiscal year for which an initial determination is made determining the number of eligible Indian students served or potentially served by a contracting party, the **Secretary shall determine** the number of eligible Indian students served by the contracting party based on the reported eligible Indian student count numbers identified through an annual reporting process.

# **Initial Count Data Concerns**

- Differences in data used by BIE: Bureau of the Census; National Center for Education Statistics; and the Office of Indian Education of the Department of Education is significant.
  - The Federal Government uses Census data in communities and individuals.
  - The Department of Interior, the <u>Bureau of Indian Affairs (BIA) uses Census data for other Indian</u> <u>programs including tribal roads, law enforcement, social services and in preparation of its American</u> <u>Indian Population and Labor Force Reports</u>.

### **Initial Student Count Determination**

Process for making the initial determination

The Secretary shall publish a preliminary report describing the number of eligible Indian students served or potentially served by each eligible entity, using the most applicable and accurate data (as determined by the Secretary in consultation with eligible entities) from the fiscal year preceding the fiscal year for which the initial determination is to be made from—

- (I) the Bureau of the Census;
- (II) the National Center for Education Statistics; or
- (III) the Office of Indian Education of the Department of Education.

### Change from Current BIE Policy

- Statistical Modeling to be used verses historic BIE student count procedure
- To improve the accuracy of the preliminary report, prior to publishing, the Secretary shall reconcile the data described in the preliminary report with:
- (I) <u>each existing contracting party's data</u> regarding the number of <u>eligible Indian students served by the</u> <u>existing contracting party for the fiscal year preceding</u> the fiscal year for which the initial determination is made;
- (II) identifiable tribal enrollment information.

### **Differences in Data**

# **Definition of Eligible JOM Student**

- a) BIE appears willing to NOT use the "eligible student" definition in operation since issuance of the 1986 Zarr vs Barlow decision (i.e., "...a member of a federally recognized tribe or 1/4<sup>th</sup> blood quantum") by indicated in the data they have drawn for review.
- b) Enrollment data only is NOT consistent with JOM eligibility definition and is likely to undercount the number of eligible students allowed by OMB Circular #15.
- c) Enrollment data will leave many "potentially eligible" students out of BIE's projection of potentially eligible students as required by the Modernization Act.
- d) What is BIE's real "Plan" for completing student count projection?

# **OMB Circular # 15 Limitations**

# OMB DIRECTIVE NO. 15, RACE AND ETHNIC STANDARDS FOR FEDERAL STATISTICS AND ADMINISTRATIVE REPORTING

- Directive No. 15 provides a minimum set of racial and ethnic categories--four categories for data on race (White, Black, American Indian or Alaskan Native, and Asian or Pacific Islander) and two categories for data on ethnicity (Hispanic origin and not of Hispanic origin).
- The current standard permits Federal agencies to use more detailed categories for collecting data on population groups, so long as the data collection is organized in a way that makes it possible for the agencies to aggregate the more detailed designations into the Directive No. 15 categories.
- For persons who identify with more than one race, <u>Directive No. 15 indicates that the single racial category which most closely reflects the individual's recognition in his or her community should be used. <u>Directive No. 15 does not provide for identifying two or more races.</u></u>
- Any approach collecting accurate data for this category would meet legislative and programs needs for most Federal agencies. The exception is the Bureau of Indian Affairs, which needs data only for federally recognized tribes and their members. Most Federal agencies use special tabulations of American Indians and Alaska Natives as one group, but data are also tabulated by tribe for some users.

### **Count Data Reconciliation**

To <u>improve the accuracy of the preliminary report</u>, the <u>Secretary shall reconcile the data</u> described in the preliminary report with:

- (I) each existing contracting party's data regarding the number of eligible Indian students served by the existing contracting party for the fiscal year preceding the fiscal year for which the initial determination is made; and
- (II) identifiable tribal enrollment information.

### Change from Current BIE Policy

- Reconciliation will improve accuracy and speed of implementation of a new student count.
- BIE's historic student count procedure lacked any means of reconciling student count numbers which were found to have higher error levels than would be statistically acceptable.

## Comment Period \*\*\*\*\*

After publishing the preliminary report, the Secretary shall establish a 60-day comment period to gain feedback about the preliminary report from eligible entities, which the Secretary shall take into consideration in preparing the final report.

### Change from Current BIE Policy

 BIE's historic student count procedure lacked any means to comment, challenge or redress count numbers due to inadvertent mistakes in reporting.

### **Final Count Report**

Not later than 120 days after concluding consultation as detailed in the Act, the Secretary shall publish a final report on the <u>initial determination of the number of eligible Indian students served or potentially to be served</u> by each eligible entity, including justification for not including any feedback gained during consultations.

### Change from Current BIE Policy

- BIE's historic student count did not consider and identify the existence of any potential JOM students (i.e., students being denied JOM services).
- Student count numbers showing the higher numbers of students that are validated by BIE strengthen arguments for increased program funding to meet the needs of all the eligible students. \*\*\*\*\*

### **Annual Student Count**

For each academic year following the fiscal year for which an initial determination is made that identifies the number of eligible Indian students served or potentially served by a contracting party, the Secretary shall determine the number of eligible Indian students served by the contracting party based on the reported eligible Indian student count numbers identified through the reporting process the contracting party shall submit to the Secretary a report describing the number of eligible Indian students who were served using amounts allocated to such party.

### Change from Current BIE Policy

Required restart of annual reporting by program contractors.

# **Identification and Recruitment of New Program Contractors**

- Current BIE Consultation suggests that potentially new contractors will simply come from existing Federally Recognized tribes.
  - i. School Districts
  - ii. Tribal Serving Organizations
  - iii. State Recognized Tribes??
- \* BIE thinking will leave Alaska, California and much of the eastern US underserved.
- **❖ No announced "recruitment plan" suggested by BIE...yet?**
- \* BIE "capability": Can BIE run a recruitment effort? Should they be given sole responsibility?

# **Data Reconciliation Process- Final Report**

The "Johnson-O'Malley Supplemental Indian Education Program Modernization Act," P.L. 115-404, Section 7 [COMPUTATION OF STUDENT COUNT], Subsection (b) [DETERMINATION OF THE NUMBER OF ELIGIBLE INDIAN STUDENTS], part 1-B-2 [DATA RECONCILIATION] provides:

"To improve the accuracy of the preliminary report described in clause (i) prior to publishing, the Secretary shall reconcile the data described in the preliminary report with— (I) each existing contracting party's data regarding the number of eligible Indian students served by the existing contracting party for the fiscal year preceding the fiscal year for which the initial determination is made; and (II) identifiable tribal enrollment information."

The Modernization Act further establishes a "COMMENT PERIOD (part iii)" that allows: "After publishing the preliminary report under clause (i) in accordance with clause (ii), the Secretary shall establish a 60-day comment period to gain feedback about the preliminary report from eligible entities, which the Secretary shall take into consideration in preparing a final report."

We currently expect this 60-day comment period (the data reconciliation process) to run from October 15, 2019 to December 15, 2019. Afterwards, the BIE will then issue a "Final Student Count" for use in calculating future funding proposals, and ultimate funding allocations for the 2020-2021 School year by April 15, 2020 (120 days after the Comment Period).

# The Big Picture

# **HOUSE BILL**

- **❖** \$44.403,000, a \$29.5 million Increase (FY 2019 vs FY2020) in BIE funding for JOM. [TPA verses BIE funding differential would end in FY 2020; this amount would be a true increase in JOM General Account funding: \$42.0 million vs \$14,835 million in FY 2019] which would be a roughly \$15.2 million for all program
- **\$2.5** million for Capacity Building/Technical Assistance.

# **SENATE BILL**

- Frozen at FY 2019 level- \$14,835: Funding to be set following release of Preliminary Student Count
- **❖** Establishes a "target per student funding level" based on the FY 2018 per student funding amount for all JOM Contractors (would end the TPA verses BIE differential)

# Committee Report Language

Johnson O'Malley.—The Committee recommends \$44,403,000 for Johnson O'Malley, \$44,403,000 above the enacted level. The Committee supports the recent enactment of the Johnson O'Malley Supplemental Education Modernization Act (P.L. 115–404). Within the funds provided for Johnson O'Malley, the Committee expects BIE to allocate \$2,500,000 in one-time funding for capacity building activities, such as performing planning activities and providing technical assistance and training based on the new law. With the remaining increased funds, the Committee directs BIE to provide funding to more tribes in order to assist more students.

### IMPLEMENTATION TIMELINE ISSUES

### **BIE JOM Annual Report**

The Secretary shall prepare an annual report, including the most recent determination of the number of eligible Indian students served by each contracting party, recommendations on appropriate funding levels for the program based on such determination, and an assessment of the contracts under the Act. This report is to be included in the budget request of the Department of the Interior for each fiscal year.

### Change from Current BIE Policy

- BIE has not historically been required to report JOM student count or program spending data to Congress, make this information publicly available or identify spending for JOM within the President's annual budget submission.
- The lack of reporting of student count and spending data has resulted in the loss of millions in annual funding since 1996.

### IMPLEMENTATION TIMELINE ISSUES

### **Funding Allocations and Reform**

BIE's annual report is required to provide the most recent determination of the number of eligible Indian students served by each contracting party and recommendations on appropriate funding levels for the program based on such student count. The Secretary may make recommendations for legislation to increase the amount of funds available per eligible Indian student through contracts under this Act to greater than the amount of funds that were available per eligible Indian student through contracts under this Act for fiscal year 1995, and attempt to identify additional sources of funding that do not reallocate existing funds otherwise utilized by Indian students served.

Under the JOM regulations (Title 25 Code of Federal Regulations (CFR) INDIANS, Part 273, 16-17), JOM programs are based on community and student needs assessments, not the needs of the school district and therefore provide specialized educational services to Indian students.


- 1. Something added to complete a thing, make up for a deficiency, or extend or strengthen the whole.

The term "supplemental educational services" generally refers to free extra academic help, such as tutoring or remedial help, that is provided to students in subjects such as reading, language arts, and math. This extra help can be provided before or after school, on weekends, or in the summer. These services are also usually focused on improving student retention and success within targeted historically difficult courses

■ Why is Curriculum an Issue?



### **Key Findings**

- Criticisms in several congressional hearings and a 1971 report by the National Association for the Advancement of Colored People Legal Defense and Educational Fund, Inc., with the cooperation of The Center for Law and Education, Harvard University.
- Identified abuses and deficiencies under the Johnson O'Malley program.
- JOM funds are primarily being used to assist in meeting [school district] maintenance and operation costs and to supplement State and local funding.
- The Indian Self-Determination and Education Assistance Act (Public Law 93-638, Jan. 4, 1975), established a national goal for JOM of providing a quantity and quality of educational services and opportunities which will assist Indian children to compete and excel in life areas of their choice and to achieve the measure of self-determination essential to their social and economic well-being (Concerns that the basic program does not contribute as much as it could toward achieving this national goal).
- Need to develop adequate criteria for determining whether basic program funds are meeting the educational needs of Indian students attending public schools,
- Seek legislative clarification from the Congress on whether basic program funds should be used to meet the minimum or higher educational standards and requirements of States.
- Strengthen the Bureau's procedures and practices to ensure that schools and school districts meet established criteria to qualify for funding.

# **Guiding Principles for Development of a New JOM Curriculum**

# A high-quality written curriculum should:

- Be culturally sensitive and equitably accessible to teachers, students, and parents
- Detail a scope and sequence of learning activities
- Establish goals and objectives
- Align assessments to standards established by NJOMA/Parent Committees
- Promote instructional activities and tools along with resources for differentiating
   JOM instruction to meet the needs of JOM students
- Exhibit recognition and be guided by best practices and research-based strategies
- Provide a universal design for JOM student learning
- Offer multiple learning opportunities for all JOM students to achieve standards
- Align JOM vertically (PreK-12) and horizontally (within grade levels), and
- Support School System/District-wide goals




