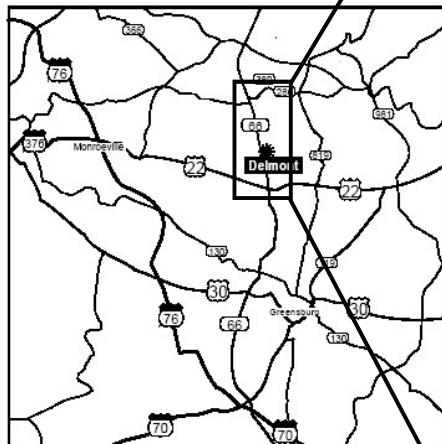
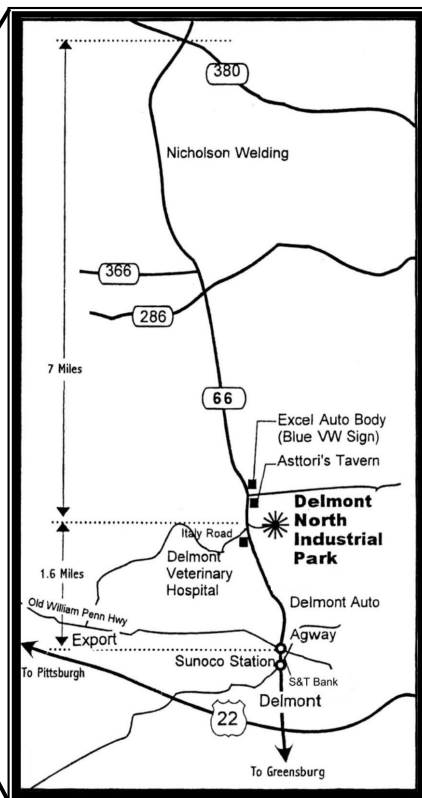


# Directions to Show Site

## From the West

Take PA Turnpike to Exit 57 (Monroeville.) After tollbooth take far right exit ramp toward Murrysville. Follow Route 22 East through Murrysville to intersection with Route 66 (10.4 miles.) Take Route 66 North ramp to Delmont.

## \*\*\*From the intersection of Rt. 22 and Rt. 66:

Continue north on Route 66 (2.9 miles) through two traffic lights, past Delmont Auto Sales on the right and Valero Century RV Sales on the left. Just after you pass the Delmont Veterinary Hospital on the left, turn RIGHT into driveway for the Delmont North Industrial Park. Continue to the buildings at the top of the hill.

## From the South or East

Take the PA Turnpike or Interstate 70 to the New Stanton interchange. Follow PA Toll Road 66 North to intersection with Route 22 (13.8 miles). Pass under Route 22 and follow directions from \*\*\*above.

## From the North

Take Route 66 South. From the Route 380 intersection, continue 7 miles South. Past the blue VW sign for Excel Auto Body, turn left into Delmont North Industrial Park. Continue to the buildings at the top of the hill.

## Farm Dog Certification Test (FDC) Information

Open to all breeds of dogs at least **9 months of age** that are individually registered with the AKC, recorded in the FSS program, dogs with PAL numbers, or dogs enrolled in the AKC Canine Partners Program. Females in season may not enter. This test involves dog performing a series of 12 exercises that are typical for a farm environment such as being in close proximity to livestock (who are always penned to avoid any altercations); jumping and staying on hay/straw bales; walking on unusual terrain; and jumping over logs. There is no herding involved. Instead, the goal is to assess his/her aptitude as a working farm dog by exhibiting self-control, confidence and trust with his/her handler.

- Non-competitive pass/fail evaluation of dog's ability to exhibit self-control in a rural farm setting.
- Dogs must be on a leash at all times while on event site unless confined in a crate, kennel or vehicle. The leash shall be four to six feet in length.
- Dogs must wear a secure, well fitting, flat collar during the test evaluation.
- Handlers can use verbal cues, hand signals and praise provided it is not excessive in the opinion of the Judge.
- Dogs may attempt each test element no more than two times.
- Dog must pass all elements of the test and overall assessment during the same test to qualify.
- Dog must qualify under two different Judges in order to qualify to be awarded the FDC suffix title.
- The Judge may discontinue testing if he/she determines the dog is too fearful or under duress to perform the required elements.
- The Judge may request the removal of any dog from the immediate test area at any time, if he/she determines the presence of the dog presents a risk to livestock, other dogs, or persons on the site.

The list of test elements is available on the AKC web site: [http://images.akc.org/pdf/FDC\\_Test\\_Guide.Revised.11.2017.pdf](http://images.akc.org/pdf/FDC_Test_Guide.Revised.11.2017.pdf) If the dog passes the FDC test on two occasions under two different Judges, the owner may apply for the suffix Farm Dog Certified (FDC) title by submitting a FDC Title Application form and a nominal processing fee. Once verified, the FDC title will be applied to the dog's record and will appear on the dog's AKC pedigree.

**Post-Dated Checks and Returned checks** do not constitute a valid entry fee. WCOTC will add a collection fee of \$25 to the amount of each returned check.

**No Refund for Duplicate Entries.** Every effort will be made to find duplicate entries; however, if the entry has been processed, no refund will be made.

**Declination of Entries.** No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Westmoreland County Obedience Training Club may decline any entries and may remove any dog because of disease, viciousness, or other cause, and no one shall have any claim against WCOTC or any official thereof.

**Entry Fees Shall Not be Refunded** in the event a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of the show committee. If because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entries will be made.

**Errors on Entry Blanks.** Owners are responsible for errors in the filling out of entry forms. Corrections cannot be made after the closing date. Please be certain that you fill in the right class and have the correct jump height on your entries. No entry and no entry fee will be refunded in event of such errors, or for cancellation of entries after the published closing date. Please type or print carefully on entry forms to eliminate errors.

**Bitches in Season** will not be admitted to the Trial. Any exhibitor with an entered bitch in season on the Trial date will be refunded the entry fee

**Exhibitors are Responsible for the Behavior of Their Dogs and/or Children.**

All dogs present must be held on leash or confined to their crates except when being judged. Exhibitors are responsible for cleaning up after their dogs. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site. In such case, no refund of any entry fees will be made.
