

**ORDINANCE NO.: 2007-04**

**AN ORDINANCE PROVIDING FOR INTENT; CHANGING THE NAME OF THE EXISTING KILLARNEY COMMUNITY DEVELOPMENT DISTRICT TO SPRING RIDGE COMMUNITY DEVELOPMENT DISTRICT AND CHANGING REFERENCES TO THE OLD NAME FROM THE ORIGINAL ENACTING ORDINANCE; PROVIDING FOR SEVERABILITY AND INCLUSION IN THE CODE; AND PROVIDING FOR AN EFFECTIVE DATE.**

**BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY, FLORIDA:**

**SECTION 1. Intent.**

It is the intent of the Hernando County Board of County Commissioners to honor the request of the Killarney Community Development District pursuant to the District Board of Directors Resolution No. 2007-2 that the name of the district be changed to Spring Ridge Community Development District.

**SECTION 2. Amending Ordinance No. 2000-14, as codified at Division 2, Chapter 23, sections 23-331 through 23-335, inclusive, Hernando County Code of Ordinances, to delete each and every reference to "Killarney" and to replace such word with the phrase "Spring Ridge."**

Hernando County Ordinance No. 2000-14, as codified at Division 2, Chapter 23, sections 23-331 through 23-335, inclusive, Hernando County Code of Ordinances, or such other location as the codifier may deem appropriate upon processing of this ordinance, is hereby amended to delete each and every reference in said ordinance and code sections to the word "Killarney" and to replace each such reference in the ordinance and code with the phrase "Spring Ridge" in order to accomplish the change of name requested by the Killarney Community Development District's Board of Directors.

**SECTION 2. Inclusion in the Code.**

It is the intention of the Board of County Commissioners of Hernando County, Florida, and it is hereby provided, that the directions in this Ordinance shall be made a part of the Code of Ordinances of Hernando County, Florida, by deleting references to "Killarney" in the above-cited Code provisions and replacing all of such references with the phrase, "Spring Ridge.". The codifier may exercise discretion in incorporating this change in the Code, which discretion shall expressly include consideration of moving the entirety of Division 2, Chapter 23, to Chapter 10.5 of the Code, if that is determined appropriate.

**SECTION 3. Severability.**

It is declared to be the intent of the board of county commissioners that if any section, subsection, clause, sentence, phrase, or provision of this ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of the remaining portions of this ordinance.

**SECTION 4. Effective date.**

This ordinance shall take effect immediately upon receipt of official acknowledgment from the office of the Secretary of State of Florida that this ordinance has been filed with said office.
