## Oak Park Estates Neighborhood Association (OPENA) Minutes of the General Meeting on March 20, 2021

The meeting started at 1:30 pm over the Zoom platform with President Tom Forsyth presiding. Tom first introduced the candidates seeking to represent District 4 in the upcoming City of Dallas elections. Each candidate was given on minute to introduce him/herself. No questions were taken. Maxi Johnson will focus on crime and economic development. Matthew Canto will focus on streets and infostructure. Incumbent Councilwoman Carolyn King Arnold stated the need for continuity in the District 4 Council seat and Johnny Aguinaga is campaigning on a theme of low-income housing. Absent was Lelani Russell.

Tom then made some announcements including:

- The upcoming Candidates Forum is set for Tuesday, April 13 at 6:30 pm. The moderator will be Anga Sanders.
- The next neighborhood cleanup will be the weekend of May 1<sup>st</sup> and 2<sup>nd</sup>.
- The OPENA Neighborhood Handbook and Directory is now available
- Oncor website can be used to report streetlights that are out
- The Master plan tor sidewalks in Dallas is available online. Resident comments and input are welcomed
- Fifteen sign toppers for the Druid Hills Addition were installed in February 2021
- Registration for the vaccine in now open at South Oak Cliff high school
- Member Jacqulyn Peel is still under Doctor's care; our prayers are encouraged.

Next was a report from the Neighborhood patrol office. Officers Martinez and Hill combined to give the update. They stated that:

(1) we should expect more officers on the street

(2) the VIP class is set to restart on April 10<sup>th</sup>

(3) recent activity on Legendary Dr. resulted from the theft of auto parts and catalytic converters. At this point only one arrest was made.

The topic for the night centered around Zoning for Single Family Neighborhoods. It was a continuation of the program on Gentrification that Paul Carden first gave to OPENA in May 2019. Tom introduced our guest speaker Paul Carden. Paul began by defining zoning and its usefulness. Zoning relates to the size of all buildings, but it is useful for neighborhood stabilization. Paul noted that while zoning tools control such things as setbacks, height and size, density and utilization are affected by demand. Tools like Historical and Stabilization Overlay are not for same size units. They are used to protect areas of distinctive and important elements of the city's historic, cultural, social, and economic landscapes.

As home owners add to existing property, they increase the density of the area. These accessary dwelling units can be rented, but the owner must live in one of the dwellings.

After Paul's program, the OPENA Officers gave their reports:

• Treasurer Beatrice Lovett reported that OPENA has \$3,450.37 in its bank account.

- Lynn Witherspoon also provided an overview of the new OPENA Neighborhood Handbook and Directory.
