Fire Chief Golden reported for the month. Total runs for the month were 43 EMS runs and 14 Fire runs. Year to date total is 124 EMS and 44 Fire. Mutual aid – Amanda 9 and Berne 8, and Lancaster 3.

OLD BUSINESS:

1. AEP with whom we have a RUMA with will be repairing the road this year.
2. Mr. Pat Marshall of Country Club Road is getting gas lines to his home and then onto lots that will be sold off. The Township has not heard back from Nate Wagner for setting up a RUMA.
3. Still have not received the resolution back from the Prosecutor's Office for marijuana growing facilities within the township.

5. Will be getting ready for FY17 paving bids.

NEW BUSINESS:


1. Trustee Ellinger mentioned that trees will be taken down around the township in the next couple months. Estimates will be received from a couple different vendors.
