**MEMA:** Kristen Jerome was unable to attend tonight, Chairman Belsito read a report from her. Next EMD meeting November 15<sup>th</sup> 9:30 am, at the Holden Public Safety Facility. If anyone needs any sandbags, sent her an e-mail.

**DCR:** D7 Warden Roy Liard: 3 ½" of rain recently. He will be out of town November 10<sup>th</sup> to 17<sup>th</sup>, he will notify the district as to who is covering for him. Call or e-mail him if there's anything you need or any surplus equipment.

#### **COMMITTEE REPORTS:**

- Training: Chief Vinson: Working on the FDSS pump class, an e-mail will go out to the district to see what interest there is in the MPO class. Should be about \$2,500 for a class, maybe split half with the department. Training Committee voted to host another Dr. Griffin class in the late winter or early spring, about PTSD and firefighter suicide. The district could pay for the class and the individual would pay for their meal, possibly at the Auburn Elks. The last class had 90 to 100 people. They will check what dates are available. They would like to have a training calendar of EMS classes, and also a roster of good instructors. Chief Vinson will send an email out to the district.

#### - Radio

Chief Hamilton: Reminder to fill out and return fact sheets for the field comm units. Next meeting November 8<sup>th</sup> in Oxford. Assisted Northbridge Fire, they now have a crossband repeater up with their new high band frequency, working with Douglas to get their new high band on with a crossband repeater. Last town left will be Mendon.

#### - FCAM

Chief Coleman: Another meeting was held regarding OSHA. Update on the PATs test, the repairs have been made and they are scheduling tests again. No new update on the Treasurer. Next meeting November 21<sup>st</sup> in Charlton.

## - Homeland Security

Chief Kochanowski: Adam Menard is leaving, no project manager, it will be posted for 14 days. Andrew Loew will be filling in for now, there will be no disruption. Cybersecurity will be the next priority but will continue to support Dive, Tech etc.

#### - Tech Rescue

Chairman Belsito: All District 7 towns are on the list now. The consortium is going good with Districts 7, 8 and 14. Working good with Tech, just met with dive and swift water, it will be a good merger. The Tech Team recent activation in Millbury went well. Chief Hamilton gave a brief description of the accident that happened at Wheelabrator when a scaffolding failed inside a boiler stranding the workers. We didn't want to put our members at risk. The Tech Team did a great job, everyone left safe.

- State Mobilization Chief Wilson: No meeting.

#### - EMS

Chairman Belsito read a report from Chief Normandin: There has been no EMS FCAM meetings. There is one scheduled in December. Meeting is to discuss Mobile Integrated Health Care (MIH) Program with the Director of OEMS. CMEMS Corp. Dr Marc Restuccia is retiring after MANY years of service as the Region 2 Medical Director. The executive board of CMEMS met last week and interviewed 2 candidates for his replacement. I will be making a recommendation to at the corporate meeting next week to approve and appoint the selected physician that will replace Dr Restuccia. There will be a formal announcement after the meeting next Thursday Nov 1 Side note: My appointment to Chief most likely will be Nov 5 at the Town Council meeting. Also, Lt Joe Hulyk will be appointed my Deputy Chief at that time also. Chief Coleman added information about Mobile Integrated Health Care and that they are looking for a guidance document for it. He will work with Chief Normandin on it through FCAM.
