INTRODUCTION

Martyn Bolt gave a reprise of previous activity. He said the Neighbourhood Plan will carry weight and will help shape the future of planning in Mirfield; not to mention attracting a higher CIL. (Community Infrastructure Levy). Cheryl Tyler said it must always be claimed.

FORWARD PLAN

Martyn Bolt has met with Cllr Julie-Stewart-Turner from Newsome. They have completed their Neighbourhood Plan. A copy of their survey was circulated. Newsome had a prize draw to encourage involvement. It was agreed that the Mirfield Residents Survey of December 2015 could be perused with a view to deciding if it would be adequate to stand as the Mirfield Neighbourhood Plan Survey. Grants are available and would be needed to cover the cost, publication and distribution etc. of a survey. Cheryl Tyler said that as Chairman of CoVoP (Community Voice on Planning), she had access to numerous completed plans. Another Committee member would be willing to come and talk to us about the Congleton Plan which is an area of similar size to Mirfield; but somewhat more rural. It was agreed that tips about pitfalls etc would be helpful. Martyn Bolt said Morley had abandoned their Plan. Meanwhile we could all get on with some research for the next meeting.
