All present had an opportunity to review and approve the minutes from the last general meeting minutes held on May 1st 2018. Followed by introductions of board members.

## Budget Review

Review 2018-2019 proposed budget. Significant income estimated \$8,000 basket raffle and \$20,000 for the fun run. The remaining $25 \%$ from usual sources (dining out, opt out, original works, Fightin Phils, Spitit Sticks). Other significant income: Membership dues $\$ 3,500$, Box Tops $\$ 1,500$, and Giant A+ Rewards $\$ 4,500$. Significant expenses or cash out flow: Assemblies/Special Events (Makers Dads and Circus) $\$ 7,650$, and equiptment purchase for a Mobile TV cart for $\$ 8,525$. Budget reflects final pavilion payment of $\$ 10,700$. Other significant expenditures: $\$ 2,150$ for annual audit, $\$ 1,800$ family fun nights, $\$ 1,000$ staff appreciation, $\$ 5,000$ to support two major fundraisers, $\$ 1,500$ spirit stick replenishing, \$3,500 for recurring assemblies, \$6,000 for \$10/student field trip, \$4,900 in teacher grants, $\$ 3,000$ for annual school shirts for teachers and staff. Two assumption notes: No income or expense amount assumed for Holiday Shoppe and fun-tivities. Budget assumes a net spend of $\$ 18,000$ during the year for an expected cash balance on 6/30/2019 of $\$ 26,500$ (starting cash balance \$44,678.25).
Year to date activity: $\$ 26,684.49$ current balance, $\$ 506$ spitit stick sales income, $\$ 2,150$ on annual audit review and tax return, \$564 to insure organization and volunteers, \$329 for A-Z directory and accounting software, $\$ 10,700$ final payment on pavilion, $\$ 4,700$ teacher grants, $\$ 600$ principals grant to Mrs. Havrilla. Budget approved.
Review updates by laws
Lisa reviewed the changes to the by-laws. Major changes included shift of responsibility (vice president/recording sercretary, and corresponding secretary), as well as the addition of a volunteer code of conduct. Vote to approve the by laws will occur at the November General member meeting.
Pavilion update - pavilion is behind schedule due to the rain. Tables need to be installed.
Upcoming events
Ram Runners Fun Run - September $21^{\text {st }} . \$ 3,570$ in donations so far, only 95 students are registered, $84 \%$ of online donors have paid the $\$ 2.50$ fee.
Water Ice Social/FIT night - night of September $21^{\text {st }}$. Social starts at 6:00, kickball at 6:30.
Fall Book Fair- e-wallet new this year as well as free book amount has raised to $\$ 6.99$ a student.
Fun-tivities - after school club \$55/student per session for 6 weeks. First sessions starting October $1^{\text {st }}$. Book club/arts, art club, bar-less barre, and chess. Clubs run from 4:00-5:15. Students must be picked up, no transportation home provided.

## New Business

California Tortilla Dining Out tomorrow (September $12^{\text {th }}$ )
Spirit Wear sale - look for an update soon on spirit wear for purchase (hoping to make this ongoing with both Spring Ford and Evans options).
Holiday Shoppe - will be in November this year, $12^{\text {th }}$ to the $16^{\text {th }}$. This year we are using five below as a vendor and this will be a community service for the school families versus a fundraiser as in previous year.
