WHEREAS, All proceedings required by law have been had and a contract has been entered into between the Trustees of Jefferson Township, Montgomery County, Ohio, and The Dayton Power & Light Company for lighting with electric; and

WHEREAS, The assessment against each of the attached list of said lots is not in excess of the special benefits resulting thereto from such lighting; and

WHEREAS, The assessments shall be paid and collected in two (2) equal annual installments in the same manner and times as taxes are paid and collected, in accordance with Section 515.108 of the Revised Code of Ohio; and

WHEREAS, The boundaries of said unincorporated districts and said assessments shall be certified to the Auditor of said County by certifying a copy of this resolution, and the Auditor shall annually place upon the tax duplicate of said county for collection in equal annual installments of said assessments for that year, as provided by Section 515.11 of the Ohio Revised Code; and

WHEREAS, The assessments, when collected, shall go in the treasury of said township and be used by the Board of Trustees, thereof, only for the said purpose for which they are levied, and are to be collected as provided by section 515.11 of the Ohio Revised Code.

NOW THEREFORE BE IT RESOLVED that this resolution shall take effect and be in force upon its passage.

Trustee Mann seconded the motion, and the roll was called on the question of its adoption.


