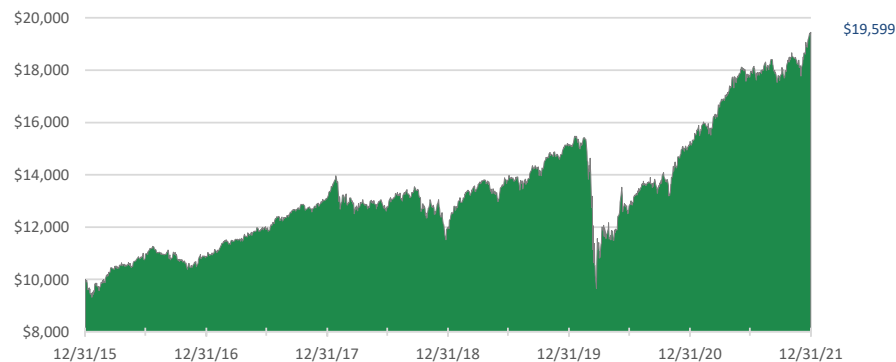

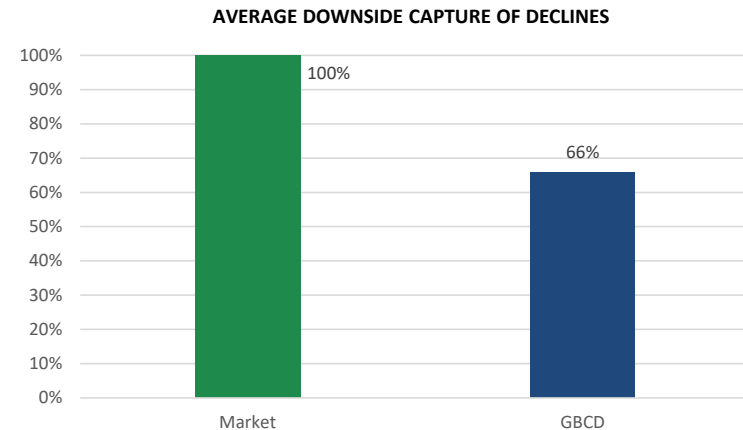
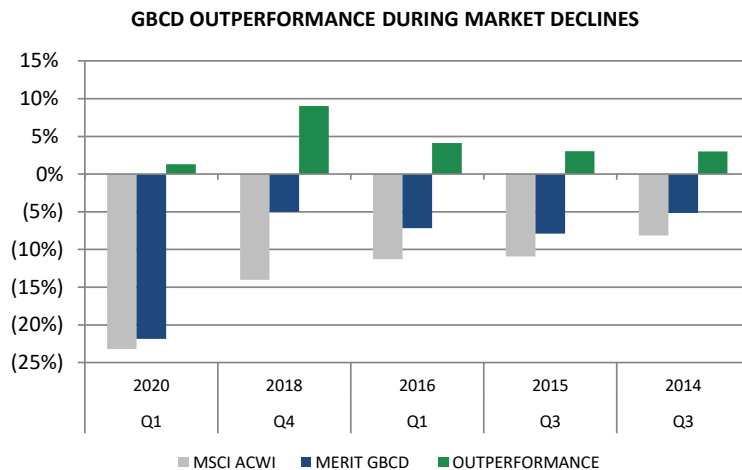
HISTORICAL PERFORMANCE ANALYSIS

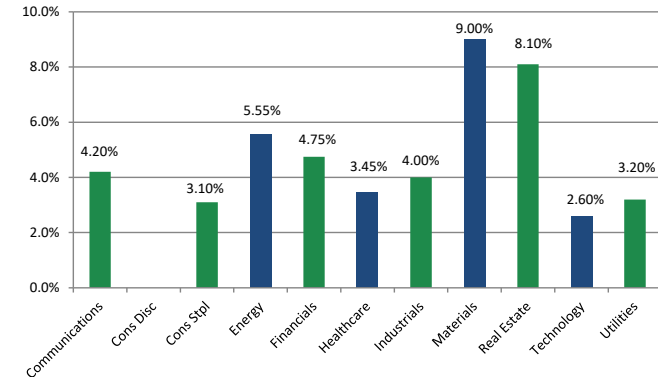
DIVIDEND YIELD & RISK METRICS

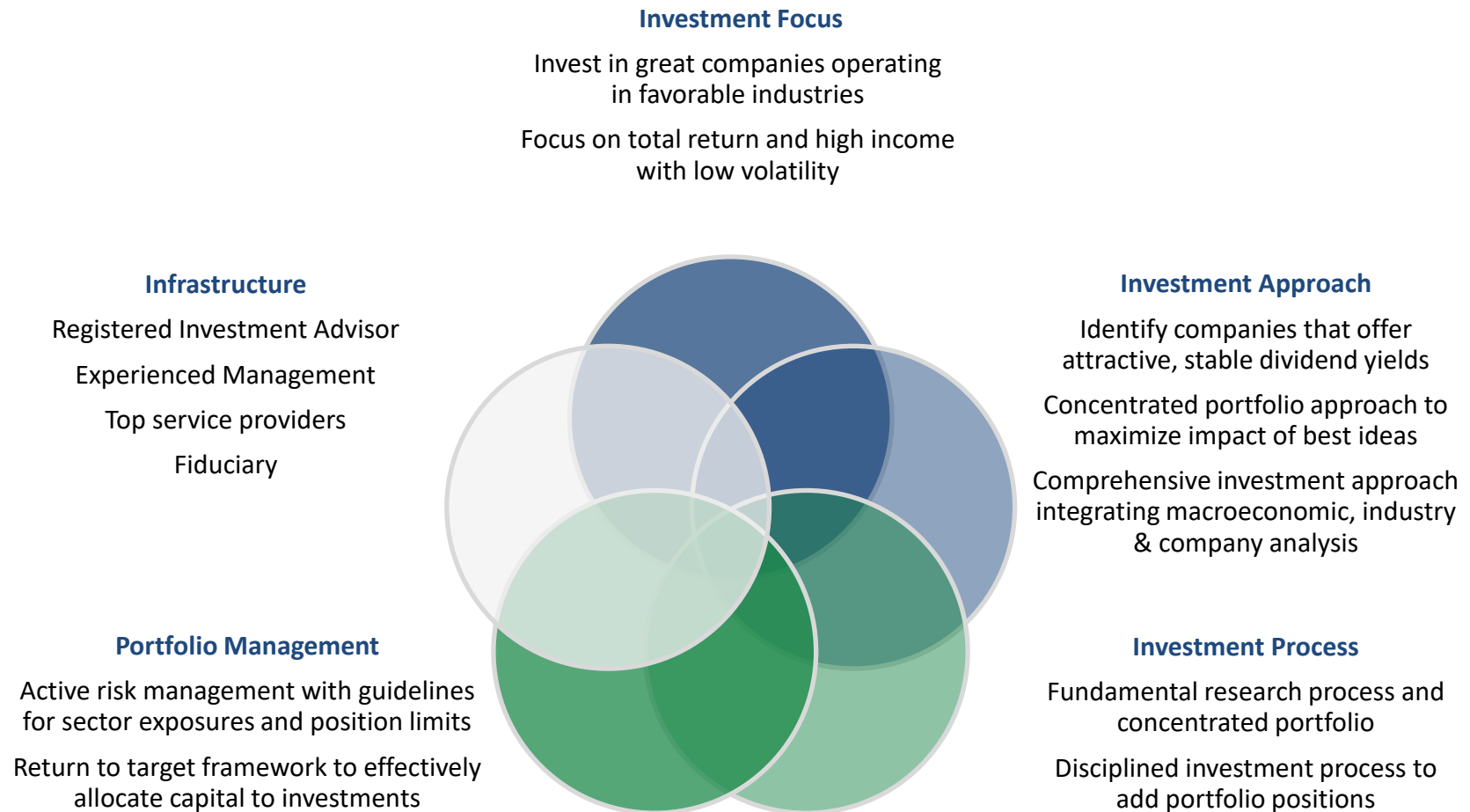
