SPECIAL MEETING OF THE BOARD OF TRUSTEES April 17,2017

- 1. Meeting called to order and roll call. Vice Mayor Stanke called the Special Meeting of the Board of Trustees to order. Clerk Hobbs called roll and declared a quorum. Agenda was posted at the Calumet Town Hall on April 12, 2017 at 12:00 pm.
- 2. Administer oath of office to Trustee 1, Terry Brungardt, Two (2) year term; Trustee 2, Mahgan Muskett, Four (4) year term; Trustee 4, Steve Snow, Four (4) year term; Treasurer, Margaret Stratton, Four (4) year term; and Town Clerk, Kelly Hobbs, Two (2) year term. Four (4) year terms expire May, 2021; Two (2) year term expires May, 2019. Town Attorney, Joe Weaver, administered oaths of office to Trustees Terry Brungardt, Mahgan Muskett, and Steve Snow; Treasurer, Margaret Stratton; and Town Clerk, Kelly Hobbs. Oaths of office were signed and notarized. Trustees Muskett and Brungardt took their seats with the other Trustees and Vice Mayor Stanke continued.
- 3. Nominations & election of Mayor/Chairman for a Two (2) year term that expires May, 2019. Vice Mayor Stanke nominated Trustee Rowell for Mayor/Chairman. Seconded by Trustee Brungardt. Vice Mayor Stanke called for any other nominations. Trustee Muskett asked for professional background, specifically supervisory experience, of Trustees to direct her vote. All Trustees gave their professional background and experience. Vice Mayor Stanke called for any other nominations; there were none. Roll call vote: Trustee Muskett, abstain; Trustee Brungardt, aye; Trustee Rowell, aye; Trustee Stanke, aye; Trustee Snow, no. Motion carried 3-2. Mayor Rowell took seat and continued meeting.
- 4. Nominations & election of Vice Mayor/Vice Chairman for a Two (2) year term that expires May, 2019. Trustee Brungardt nominated Trustee Stanke as Vice Mayor/Vice Chairman. Seconded by Trustee Rowell. No other nominations. Roll call vote: Trustee Muskett, abstain; Trustee Brungardt, aye; Trustee Rowell, aye; Trustee Stanke, aye; Trustee Snow, no. Motion carried 3-2.
- 5. Appointment of primary and alternate delegate(s) to ACOG Board of Directors and Garber-Wellington Association Policy Committee, with action as necessary. Mayor Rowell

Trustee Snow made a motion to appoint Trustee Stanke as alternate delegate 2. Seconded by Trustee Rowell. Roll call vote: Trustee Muskett, aye; Trustee Brungardt, aye; Trustee Rowell, aye; Trustee Stanke, aye; Trustee Snow, aye. Motion carried.
