*Official Meeting Minutes from January 5th 2021 meeting

- **Treasurer's Report-** Current balance \$8437.90 and \$30,000 in savings. The first grooming payment has not been received yet. Per VAST, LLC type needs to be defined. December club dues not received yet. The Treasurer's report was motioned to be accepted as read, by Dale Sutherland and seconded by Jennica Forrest. It was voted on unanimously to accept.
- **Secretary's Report-**The December 1st meeting minutes was motioned to be accepted as read by John Napier and seconded by Mike Poulin. It was voted on unanimously to accept.

#### **Vice President's Report**
