Pumps and Pistols Course for Women Only - This is a three hour class and limited to three people at a time and taught by the NRE residents/owners

Class has four parts and includes all ammo and the loan of a firearm.

- 1. <u>Safety</u>: The Four Commandments of Firearms Safety safety in the home and on the range.
- 2. Language of Firearms:

Cartridges/rounds vs. bullets, caliber vs. millimeter, clip vs. magazine double action or single action, and other elements of the lexicon.

- 3. The Mechanics of Firearms
 Operation: Parts of the pistol and revolver, how to load and unload them safely, and how they function.
 If needed selecting a handgun that fits YOU: grip size, trigger span, recoil? Working towards finding the right handgun for you and what you want to use it for. Help with ammunition choices as well.
- 4. The Fundamentals of Marksmanship: Proper grip, stance, trigger control, and other essentials to achieving accuracy. Live-Fire on the range: Private coaching with your instructor while you fire your handgun, using the skills and techniques you learned from the discussion portion.

Crime Watch

Sign Run Over – The stop sign at the corner of Nolan River and Gold Cup was found flat on the ground Monday, 6 June. It was reinstalled right away by Precinct 1.

Animal Safety

In the unincorporated areas of Johnson there is no ordinance concerning the tethering or restraint of your dogs. While this is true, the misconception takes place when dog owners think there is nothing that can be done. This leads to people allowing their dogs to roam freely. When dogs are unsupervised and under socialized, they tend to revert back to their natural state. When this happens, it can trigger instinct of the dog's territorial aggression.

Please keep in mind that you may not be required to tether your dog. However, you are still responsible for the actions of the dog when it is running around. If your dog attacks another person, domestic animal, livestock, or fowl, you may be in violation of a criminal law under the Texas Health and Safety Code.



"Certain Dogs...[are] Prohibited from Running At Large" ...[by] the owner, keeper, or person in control of a dog that is accustomed to run, worry, or kill livestock, domestic animals, or fowls [and] may not permit the dog to run at large. This same code under Subchapter D states that if your dog attacks a person and by that attack you are placed in reasonable fear of serious bodily injury, your dog may be declared to be a Dangerous Dog.

For more information about the requirements of keeping a dangerous dog, please refer to the Texas Health and Safety Code Chapter 822 Sub Chapter D.
