## A. MAYOR:

Ordinance No.: 2019-**03**: Adopting and Amending ordinance No. 2018-64 (Permanent 2019 Appropriations) by appropriating from unappropriated funds in the General Fund, the Street Construction, Maintenance and Repair Fund, the Water Fund, and the Sewer Fund and declaring an emergency. This constitutes a first reading of said ordinance. It was moved by Councilperson Shaver, seconded by Councilperson Dillon to suspend the three-reading rule; passed by six (6) votes. The three-reading rule was suspended. It was moved by Councilperson Lake, seconded by Councilperson Shaver to adopt; passed by six (6) votes. The ordinance was adopted.

Councilperson Schuld read a letter by Bill Reineke regarding the Sunny Farm Land Fill.
