

Web administrator report for Annual Meeting, February 4, 2024

Cheltenham Chamber of Citizens (CCC) depends of 3 forms of media to communicate with our members and the community at large. As is stated in our By-laws, our purpose is:

E-Mail

E-mails are sent through Constant Contact. We chose this vehicle to eliminate the possibility of spammers reaching our group. If you inadvertently unsubscribe yourself, you will have to re-sign up to continue to receive e-mails, another precaution.

Our e-mail list has been growing this past year. Our open rate averages 53%.

We keep the subject line specific to the topic of the e-mail, so those who have an interest will open and read the e-mail.
