AMENDMENT TO AGREEMENT

THIS AGREEMENT, bearing the date set forth below, by and between the County of Dutchess, a municipal corporation of the State of New York, with its principal offices at 22 Market Street, Poughkeepsie, New York 12601 ("County") and VILLAGE OF MILLERTON ("Cooperating Municipality"), having offices at 21 Dutchess Ave., Millerton, New York 12546, to amend the existing Cooperation Agreement County Contract Number 00-0408-PL, dated July 6, 2000, as amended, (Amendment to Urban County Cooperation Agreement County Contract Number 00-408-PL-A3, dated May 18, 2009), as follows:

- 1. A paragraph "14" shall be added to read as follows:
 - 14. The Cooperating Municipality and the County of Dutchess may not sell, trade, or otherwise transfer all or any portion of the Community Development Block Grant funds to any other metropolitan city, urban county, unit of local government, or Indian tribe, or insular area that directly or indirectly receives Community Development Block Grant funds in exchange for any other funds, credits or non-Federal consideration, but must use such funds for activities eligible under the Act.
- 2. A paragraph "15" shall be added to read as follows:
 - 15. In addition to the certifications provided for in Paragraph "11" of the original Cooperation Agreement, the County and Cooperating Municipality hereby agree to affirmatively further fair housing, and comply with Section 504 of the Rehabilitation Act of 1973 and the Age Discrimination Act of 1975.

In all other respects, the provisions of the prior Cooperation Agreement dated July 6, 2000, as amended, shall remain in full force and effect and shall be binding upon the parties referred to below.

WHEREAS, the County of Dutchess and the VILLAGE OF MILLERTON entered into an existing Cooperation Agreement dated June 29, 2000, as amended, to form the Dutchess County Urban County Consortium for the purpose of undertaking the CDBG and HOME Programs, and

WHEREAS, the existing Cooperation Agreement must be amended as specified in Schedule A attached, and

WHEREAS, the Board deems it to be in the public interest for the Cooperating Municipality to renew the existing Cooperation Agreement for 2016-2018 in accordance with Paragraph 3 of the Cooperation Agreement and into enter into an amendment to the Cooperation Agreement, attached, now, therefore, be it
