**DEFENDANT BRUCE PATNER'S CONSENT MOTION  
FOR LEAVE TO FILE A MEMORANDUM IN OPPOSITION TO  
PLAINTIFFS' MOTION FOR CERTIFICATION OF THE  
DEFENDANT CLASS IN EXCESS OF FIFTEEN PAGES**

Defendant Bruce Patner moves the Court for leave to file a memorandum in opposition to Plaintiffs' Motion for Certification of the Defendant Class in excess of fifteen pages.

The standard Scheduling Order, which issued from this Court on June 22, 2016, provides that memorandums in opposition to a motion may not exceed fifteen pages without leave of the Court.

On August 20, 2016, Plaintiffs filed a motion for certification of a defendant class supported by a 36-page memorandum. The memorandum raises numerous issues of significant importance that require a response from Mr. Patner. Mr. Patner does not believe he can adequately respond to the motion with an opposition of only fifteen pages.

Mr. Patner requests that he be allowed to file an opposition of 36-pages, the length of the memorandum that Plaintiffs filed.

Undersigned counsel spoke with counsel for Plaintiffs, Richard Gordon, on September 8, 2016, and asked for his consent to the requested relief. Mr. Gordon gave his consent.

Accordingly, Mr. Patner requests leave to file a memorandum in opposition to Plaintiffs' motion for certification of no more than 36 pages.


