Financial Overview

- The Parking Authority had revenue of \$25,741 in April 2021. Total revenue for the month was \$26,692 higher than the previous March. This was the beginning of the COVID-19 shutdown. Total expenses were \$41,727. A reduction of \$21,742 compared to the previous year. Net revenue was (\$15,987). This was still an improvement of \$48,434 compared to March 2020. March 2021 had three payroll cycles and this contributed to the negative net revenue for the month.
- YTD revenue for the Parking Authority was \$196,480 as of April 30, 2021. A reduction of \$61,569 from 2020. YTD expenses were \$120,690 a reduction of \$116,579 from the previous year. YTD net revenue was \$75,789.
 - Total available funds as of 5/27/21 was \$11,093
 - Outstanding payables as of 5/27/21 was \$69,431 plus \$150,179 of employer's pension contribution.
 - Total loan balances as of 5/27/21 was \$92,054 plus \$450,000 pending for NJT.
- The Park and Ride had revenue of \$6,591 in April 2021. An increase of \$6,591 compared to March 2020. Expenses were \$16,178 compared to \$14,689 in March of 2020, a increase of \$1,489. This was a result of the timing of a propane tank refill. Net revenue is still a deficit of (\$9,587) compared to \$(14,689) in 2020. Even though net revenue is still a deficit there was an improvement of \$5,102. YTD revenue for the first quarter of 2021 was \$44,255 compared to \$110,430 in 2020. A reduction of \$66,175. YTD expenses were \$69,257 compared to \$78,506 in 2020. A reduction of \$9,250. YTD net revenue was (\$25,002) compared to \$31,924 in 2020. This is a decline of \$56,925.
 - Total available funds as of 5/27/21 was \$4,864
 - Outstanding payables as of 5/27/21 was \$221,418
 - General payables was \$3,666, status current
 - NJT Draw \$48,000
 - Due to Parking Authority \$169,752

Unfinished Business

- **Bobcat Sale:** The Township has stated that they are interested in purchasing the Bobcat for \$40,000. They are preparing a resolution for approval by the Governing Body..
- NJT Status: This is an on-going issue.
- **Refinance Meter Loan:** Still in process.

- Lawn Care: The riding lawn mower needed to be picked up by Blossom Lawn to have a new belt put on. The Park and Ride has been mowed. The Township did a one time favor and mowed the Huddy Park lot. Once the riding lawn mower is returned, then Lot H and E will be mowed. The Authority needs to purchase a walk behind mower and a weed trimmer. The purchase for this equipment was not approved. Pam Piner said she would reach out to the Township to see if an shared services agreement could be entered into.
- Marine Building Utilities: The Township is having the utility accounts transferred to them.

New Business

- **FEMA Snow Emergency Funding:** The MUA Executive Director informed Pam Piner about a grant from FEMA that would assist in paying any snow plow expenses for the year 2021. Ms. Piner said she applied for this grant and is waiting to hear if the Authority will receive any funds.
- **Broadway Opening Date:** Broadway has been scheduled to reopen on September 1, 2021. Ticket sales have already started for 4 shows. This will play an important part in the Park and Ride returning to normal activity.
- 2021 Budget Adoption: This topic was not discussed.

General Discussion

A general discussion took place regarding several topics. Renegotiating the NJT contract, the sale of the parking lot owned by the Authority and the PERS Employer's pension contribution payable. A working session was scheduled for June 21, 2021 in order to discuss these topics in detail and to identify any possible resolutions. The regular meeting was also moved to be held immediately following the working session instead of the normal date of June 24th.
