AN ORDINANCE BY THE COUNCIL OF AMELIA VILLAGE, OHIO ADOPTING THE PERMANENT ANNUAL APPROPRIATIONS OF VILLAGE FUNDS FOR THE FISCAL YEAR ENDING DECEMBER 31, 2017 FOR AMELIA VILLAGE

WHEREAS, the Village is required by statute to prepare and adopt annual permanent appropriations of village revenues for current expenses and other expenditures for the fiscal year ending December 31, 2017.

WHEREAS, the Village may adopt temporary annual appropriations for the fiscal year ending December 31, 2017 with permanent appropriations being adopted by March 31, 2017.

SECTION IV. That this Ordinance shall take effect and be in force at the earliest time allowed by law.
