Rockford Town Council Regular Meeting

June 7, 2023, 7pm

Mayor Carrie Roecks called the regular meeting to order at 7:00pm with the Pledge of Allegiance.

Roll call took place. Those present were Mayor Carrie Roecks, Councilmembers Clint Stevenson, Tim Fricke, Micki Harnois and Walt Whitman. Clerk/Treasurer Heidi Johnson and Public Works' Dave Thompson were also in attendance.

Ms. Harnois made a motion to excuse Councilmember Kevin Wills, due to medical reasons. Mr. Fricke seconded the motion. Motion was carried.

Layne Merritt, JUB Engineers, Inc.

Mr. Merritt gave Council an updated agreement for the Sewer Improvement project. He explained the update was just the timeline for bidding and starting the project. There was discussion about the best time to request bids. Mr. Merritt also explained that the budgeted amounts reflected on the agreement/grant documents from Spokane County may need to be adjusted. After receiving quotes from JUB's subs, the budgeted line items for engineering could overrun about \$10,000. Mrs. Johnson said that the budget can be adjusted within 10% without an amendment to the Spokane County agreement. Mr. Merritt said that JUB will do their best to save in other areas to help offset the \$10,000 difference, but worse case scenario would be that the Town would have to use its own funds to cover the remainder. The council agreed.
