**Joanne Bonnevenia** – Spoke about the history of her obtaining the title for a property in the Town Center Zone which was around January of 2023 and how she learned of the upcoming changes to the Town Center Zoning. She noted that some of the Board members caused her financial burden and stress with the lawsuit that was filed against Dutchess County involving the property she recently purchased. She noted she will fight to be placed back into the Town Center zoning and voiced her opinion on putting restrictions on commercial building maximum square footage of 2500 sq. ft. She believes this should not be voted on tonight and pointed out that Union Vale lost the lawsuit against Dutchess County. She feels the 2500 square footage is not cost effective for the much-needed commercial building needed in the town of Union Vale.

Since there were no further public comments Supervisor Frazier closed the public hearing at 7:08pm which was motioned by Councilman Cartalemi and seconded by Councilman McGivney.

Supervisor Frazier called the meeting to Order to Order and Salute to the Flag at 7:30PM.

**Motion to Change Agenda**

Supervisor Frazier made a motion to move the executive session to the end of the meeting and the resolution of adoption to the beginning which was seconded by Councilman Welsh and all were unanimously in favor.

**Resolution #22-2024 A LOCAL LAW AMENDING TOWN CODE CHAPTER 192, “SUBDIVISION OF LAND” AT §192-3, THE DEFINITION OF A MAJOR SUBDIVISION; CHAPTER 210, “ZONING” AT §210, ATTACHMENT #3, DESIGN STANDARDS FOR THE TCDISTRICT AT C(13) (E) RE THE MAXIMUM SQUARE FOOTAGE FOR COMMERCIAL USE STRUCTURES IN THE TC ZONE, AND CHAPTER A215 “STREET SPECIFICATIONS” AT FIGURES 1, 1A AND 5 RE PRIVATE STREET WIDTH SPECIFICATIONS**

Councilman Cartalemi discussed the county’s response which was regarding road width. This was established by the Fire Code and the Fire Advisory Board who made the recommendation between the 20-26 feet regarding the fire code. The County’s response inquired as to where it was sited and Councilman Cartalemi pointed out that it is in the fire code as it was not referenced in the local law but is on file.

**Motion Approve Minutes:** Councilman Welsh made a motion to approve the April 3, 2024 Meeting minutes which was seconded by Councilman Cartalemi and all were unanimously in favor.

**Supervisors Report**

- Supervisor report 15 yards of trash, nice turn out and went well, good fellowship, he thanked Councilman McGivney as he assisted picking up all the trash bags on the roadside

### **Board Member Reports**

*Councilman Welsh* – mentioned it was a good crew that volunteered for cleanup day, especially on Wingdale Mountain Road. He has been looking into the roof which he can add in later in the meeting, looked into state regulations and feels the procurement policy should be updated prior to moving forward. Potters corners cemetery thanks the Parks dept, as it looks fabulous.

*Councilman Cartalemi*- advised DC is holding their hazardous waste event, you must pre-register on their website and does fill up quickly, there is a \$10 fee.

*Councilman Durland* – commented on the trash clean up and the staggering amount, he was happy to participate in the event.

*Councilman McGivney*- earth day great success, 4 out of 5 board members and Deputy Supervisor, Kevin Harrington, and thank volunteers in the community and fire dept. thank you to UVFD for pizza post-clean up. Filled a 40-yard dumpster about halfway. Spring Fling horse show on Sunday, many spectators and Loretta Ryan, Director did a great job. Lastly, he visited the Recycling center and they thanked the Board for their sign Board.

*Supervisor Frazier* also noted that after a resident made a request for a “no littering” sign it was placed by the Highway Superintendent the following day.

**Town Clerk Report** Clerk Casey stated Trash Clean up Captain Oliver Herta was very excited to see the sign and a picture was provided by the family. June 5<sup>th</sup>, document shredding day, please call to get on the truck arrival list.

### **Recreation, submitted by Recreation Director Maggie Collins**

Last Friday we hosted another successful Adult Paint and Sip event. Thank you to all the patrons who attended this fun evening, and to our instructor Amanda Smalley for helping participants to make their own masterpieces. Future programming will be posted on our social media pages and our Parks and Recreation website once it is scheduled and open for registration. Next Friday we will be running our TGTT program for the Arlington School District’s half day. Parents and guardians can register their children in grades K-5th and coordinate bus transportation to the park to enjoy crafts, themed activities, and fun with friends in our park. More information and registration can be found at our Parks and Recreation website. This Friday we will be hosting an AARP Smart Driving Course at Town Hall. Participants can take the course to receive up to 10% off of their car insurance. This is a two-day course so participants must attend the class on May 3rd and May 10th. Both of those dates will run from 9am-12pm and there is no test required to complete the course. The course is \$25 for members of AARP and \$30 for non-members, this fee will be collected on the first day of the course and paid for with either a check made out to AARP or exact cash. You must bring your ID and AARP card if applicable. Online registration is required to sign up for this course and seating is limited. More information and registration can be found at our website.

Registration for pool memberships and public swim lessons is still open and can be found on the Parks and Recreation website, as well as pool hours for the Summer season.

We still have some seats left for our TLC program for all four sessions. Parents and guardians can register their teen online at the Parks and Rec website.

### **Parks Report May 2024 Submitted by Vincent Germano**

- #11 has been cleaned and is ready for the tenants to move in.
- We have reoriented one of our upper soccer fields to better accommodate the groups that utilize it and to allow grass to regrow in spots that had been torn up, we have put top soil and planted grass seed in various areas around the park that needed it.
- We continue to mow all areas of the park, town hall, and equestrian center. As well as maintaining the various trails around the park, taking care of fallen trees and debris.
- After dealing with a minor water leak all of the seasonal bathrooms other than Godfrey park are now up and running and usable during the hours the park is open. Godfrey park is next on the list and should be available soon.
- A large branch fell and took the power lines and phone lines off the #2 rental house yesterday. They were still attached to the meter so there was still power to the house, Central Hudson came out and temporarily reattached it to the building and an electrician came out today to do the final repair. We are working on removing the branch now that it is safe to do so.

- Some of the leaks in the roof of the main park building caused damage to the interior sheetrock in the large hall, we have attempted to better catch the water in the attic and have repaired the sheetrock so it is fit for use by the people that rent the space.

### **Historical Society**

President, Cassandra Redinger informed the residents that they meet once a month on the second Wednesday of each month. She spoke about the historical picture campaign and noted that the new website has been linked to the Town Website. The Germond Family Murders 92-year-old cold case review will be June 13<sup>th</sup>.

### **Library Report**

Library Trustee President, Amy Watkins spoke about updates from the Library:

- The library is excited to share that we have hired our new Library Director. Karen Foley has been a Union Vale resident since 1998. She began her journey at SUNY Oswego, where she earned a B.A. in Communication Studies. In addition to raising her family, Karen's ongoing involvement in volunteering with diverse community organizations highlights her commitment to service. She spent 8 years as a volunteer in Vail Farm and Union Vale Middle school libraries and also served as a reading mentor. Karen will help bring the Union Vale Library's vision to life by fostering an inclusive and enriching environment for all members of our community. Her dedication to service and her genuine passion for libraries make her a valuable asset to the Union Vale Library team, ensuring its continued growth and success for years to come.
- Several of the Trustees and Library Director met with Maggie and the Rec Department to discuss the Summer Camp and needs for the shared space. We have worked out a plan to provide campers access to the library on rainy days. We also encourage families to use pick-up time as a great time to check out books.
- For the summer, Karen is already planning fun, family events including Campfire Stories. More to follow. To stay up-to date with programming, sign up to receive our emails. There is a link on our website on the main page!
- As mentioned in March, we received a sizable donation of books from the Estate of Jeanette and Paul Wagner. Karen has started sorting through these books and identifying unique collections to share with our community.
- As you may recall, we recently requested membership to the Southeastern NY Library Resources Council. We are now working with the Town of Union Vale Historical Society to provide the Town the opportunity to digitally scan and archive our historical records. These conversations are still taking place, but we are excited to watch this partnership develop in the coming months as there is some much to plan together.
- The Union Vale library participated in the Neighborhood Forest tree planting program. Town of Union Vale families came to the library to receive their free trees.
- Overdrive/Libby is working. Our Director is currently testing the site with our library cards to ensure it is working as designed. Residents who are interested in learning more about how to use the system can email the Director at [director@uvlibrary.org](mailto:director@uvlibrary.org). You will need to register for your library card. Once you have your library card, you will be able to access Kanopy, PressReader and OverDrive and take out physical copies of books in our library. If you don't see what you want, ask the Director and we will order it for you!
- Website update: The trustees have been working to revamp our website to be more user-friendly, with easy navigation for our residents. We are hopeful to launch the new site by the end of the month, this will include our new logo!
- We have an update on our Charter. The Division of Library Development is in the FINAL stages of reviewing our application. They have requested an additional piece of documentation not initially requested on the original application. The Certificate of Establishment of the Library was certified and sent the next day. We look forward to more updates in the coming weeks.

**Public Comment Agenda Items-** None

**Roof Replacement Update-** Engineer will have the scope drawn up soon. Procurement should include and this would be a quick resolution to allow the TIPS program. Attorney Battistoni advised that it is a good point to update the policy to include the authorization of using TIPS. Supervisor Frazier will have this drawn up for the next meeting to include using NYS Approved purchasing contracts.

Councilman Welsh checked with the Fire House in Lagrange and the Wingdale elementary school had positive things to say about their reliability and workmanship.

Councilman Cartalemi asked about any other repairs, Supervisor Frazier said Bob Turner is supposed to be out to secure the cupola.

**Discussion of Portable Toilets**

Councilman Cartalemi stated that he obtained 2 quotes and Supervisor Frazier got a 3<sup>rd</sup> and one from our current provider Jones Septic along with an ADA toilet for the Equestrian Center. Seek-Seat cheapest, Jones does not offer an ADA toilet, after comparing the numbers and the quote timeline, Seek-a-Seat comes out the most cost effective and donates \$5 to veterans \$90/month for standard. It would save \$70 a month for 2 units. Reliable is a local company is Wappingers that the Supervisor also provided a quote from.

Councilman Frazier has only reservations about moving business outside of Dutchess County due to sales tax. This will be on the agenda next month after the Board has a chance to review.

**Executive Session** Supervisor Frazier made a motion to enter executive session to discuss possible litigation, which was seconded by Councilman Welsh and all were unanimously in favor.

**Executive Session** Councilman Welsh made a motion to exit executive session to resume the regular meeting which was seconded by Councilman McGivney and all were unanimously in favor.

Supervisor Frazier advised the Town would not peruse the appeal for the Dutchess County foreclosure property case. He would like to entertain a motion to notify the attorney.

Councilman Cartalemi made a motion to no longer peruse the appeal and to authorize the Town Supervisor to sign any paperwork which was seconded by Councilman McGivney.

**RESOLUTION OF ADOPTION**

**Local Law # 1 of 2024**

**A LOCAL LAW AMENDING TOWN CODE CHAPTER 192, “SUBDIVISION OF LAND” AT §192-3, THE DEFINITION OF A MAJOR SUBDIVISION; CHAPTER 210, “ZONING” AT §210, ATTACHMENT #3, DESIGN STANDARDS FOR THE TC DISTRICT AT C(13) (E) RE THE MAXIMUM SQUARE FOOTAGE FOR COMMERCIAL USE STRUCTURES IN THE TC ZONE, AND CHAPTER A215 “STREET SPECIFICATIONS” AT FIGURES 1, 1A AND 5 RE PRIVATE STREET WIDTH SPECIFICATIONS**

The following Resolution was offered by Councilman Welsh and seconded by Councilman Cartalemi, who moved its adoption:

***WHEREAS***, a Local Law was introduced by the Town Board of the Town of Union Vale as Local Law #1 – 2024, entitled “A LOCAL LAW AMENDING TOWN CODE CHAPTER 192, “SUBDIVISION OF LAND” AT §192-3, THE DEFINITION OF A MAJOR SUBDIVISION; CHAPTER 210, “ZONING” AT §210, ATTACHMENT #3, DESIGN STANDARDS FOR THE TC DISTRICT AT C(13) (E) RE THE MAXIMUM SQUARE FOOTAGE FOR COMMERCIAL USE STRUCTURES IN THE TC ZONE, AND CHAPTER A215 “STREET SPECIFICATIONS” AT FIGURES 1, 1A AND 5 RE PRIVATE STREET WIDTH SPECIFICATIONS; and

***WHEREAS***, a copy of the proposed Local Law No. 1 is attached hereto as Exhibit A and incorporated herein, with the language to be added underlined and the language to be deleted ~~stricken~~, and the Town Board does hereby waive a verbatim reading of said Local Law and directs that said Local Law be spread across the record as if it, in fact, had been read verbatim; and

***WHEREAS***, a public hearing in relation to said Local Law was held on May 1, 2024 at 7:00 p.m., Prevailing Time, at the Union Vale Town Hall, 249 Duncan Road, LaGrangeville, New York; and

***WHEREAS***, notice of said public hearing was given pursuant to the terms and provisions of the Municipal Home Rule Law and the General Municipal Law of the State of New York, and the Union Vale Town Code; and

**WHEREAS**, a copy of the Resolution of Introduction, the proposed Local Law, a copy of the draft Environmental Assessment Form and the Notice of Public Hearing have been provided to the Dutchess County Department of Planning and Development for its consideration pursuant to General Municipal Law §239-m, and

**WHEREAS**, the County of Dutchess has advised on May 1, 2024, pursuant to General Municipal Law §239-m that it considers the adoption of this Local Law to be a matter of local concern; and

**WHEREAS**, because this Local Law involves an amendment of the Town's Zoning Code, the Town Board is the only Involved Agency for purposes of conducting the environmental review of it, and

**WHEREAS**, the Town of Union Vale Planning Board has provided an Advisory Opinion in support of the adoption of this Local Law, and

**WHEREAS**, said Local Law has been on the desks of the members of the Town Board of the Town of Union Vale for at least seven (7) days, exclusive of Sunday, *now, therefore*,

**BE IT RESOLVED** that the Supervisor is authorized to execute the Draft Environmental Assessment Form Part I previously submitted to this Board; and

**BE IT FURTHER RESOLVED**, that as the only Involved Agency, this Board determines that this action is a Type I Action and that it wishes to serve as the Lead Agency for the environmental review of it, and

**BE IT FURTHER RESOLVED** that the Town of Union Vale Town Board assumes Lead Agency status to perform the environmental review of this Local Law; and

**BE IT FURTHER RESOLVED** that after review of the full Environmental Assessment Form annexed at Exhibit B hereto and on consideration of the terms of the proposed Local Law

as well as all of the proceedings had and documentation submitted regarding it, this Board does determine that its adoption will not have any significant adverse environmental impacts; and

***BE IT FURTHER RESOLVED*** that the Supervisor or his designee is authorized to respond in the negative or not applicable in response to the questions regarding potential adverse environmental impacts in Part II of the Environmental Assessment Form, and

***BE IT FURTHER RESOLVED*** that this Board adopts a Negative Declaration under SEQRA and authorizes the Supervisor or his designee to so endorse Part III of the Environmental Assessment Form, and


***BE IT FURTHER RESOLVED*** that the annexed Local Law be and the same is hereby enacted: TOWN OF UNION VALE LOCAL LAW #1 OF 2024 entitled A LOCAL LAW AMENDING TOWN CODE CHAPTER 192, “SUBDIVISION OF LAND” AT §192-3, THE DEFINITION OF A MAJOR SUBDIVISION; CHAPTER 210, “ZONING” AT §210, ATTACHMENT #3, DESIGN STANDARDS FOR THE TC DISTRICT AT C(13) (E) RE THE MAXIMUM SQUARE FOOTAGE FOR COMMERCIAL USE STRUCTURES IN THE TC ZONE, AND CHAPTER A215 “STREET SPECIFICATIONS” AT FIGURES 1, 1A AND 5 RE PRIVATE STREET WIDTH SPECIFICATIONS”; and

***BE IT FURTHER RESOLVED*** that this Local Law shall take effect upon adoption by the Town Board and filing with the New York State Secretary of State in accordance with applicable provisions of law, and specifically Article 3, §27 of the Municipal Home Rule Law.





3. A CURTAIN DRAIN SHALL BE INSTALLED WHEREVER GRADE SLOPES TOWARD THE TOWN ROAD, OR AS DIRECTED BY THE TOWN HIGHWAY SUPERINTENDENT OR TOWN ENGINEER.
4. AN UNDER DRAIN MAY BE REQUIRED BY THE TOWN HIGHWAY SUPERINTENDENT OR TOWN ENGINEER, IN LIEU OF, OR IN ADDITION TO A CURTAIN DRAIN.

5. THE TOPSOILED SHOULDER AREA SHALL BE PLANTED WITH A MIXTURE OF EMPIRE BIRDSFOOT TREFOIL OR COMMON WHITE CLOVER (8 LBS PER ACRE), TALL FESCUE (20 LBS PER ACRE), REDTOP OR PERENNIAL RYE GRASS (5 LBS PER ACRE).
