NOTICE TO EXHIBITORS

*The safety of the dogs is the primary concern so by entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

*Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.

*It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. If an exhibitor is asked to leave the trial site, then the exhibitor will not be refunded any fees that have been paid.

*Entry fees will not be refunded if a dog is disqualified, excused, or barred from competition by action of the show committee. There shall be no refunds for entries withdrawn after the closing unless circumstances warranted are approved by the trial chair. Circumstances may include bitches in heat, injury or illness to dog or handler. The chair may authorize a 50% refund of entry fees if the request is received in writing including a veterinarian or physician note by the Trial Secretary BEFORE the day of show. Also, no entry fee will be refunded if the trial cannot open or be completed for reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

*Returned checks for any reason will incur a charge of \$30 plus bank charges. These are defined as ANY check that does not clear our bank the first and second time it is deposited. **All entry fees will be deposited promptly following the closing date. Please plan accordingly.**

*Overpayments of entry fees will not be refunded. Please check your math carefully!

*Exhibitors are responsible for complete, accurate, and legible information on the entry forms. Any illegible or incomplete entries will not be entered in the trial.
