Releases, Rules & Regulations

1. Show hours are Friday, March 18, 2016 and Saturday, March 19, 2016 from 10 a.m. to 4 p.m. The Garden Party itself will occur on Friday night from 7 p.m. to 11 p.m. Booths are expected to be open during the full time of each session, including the Party. Vendors are requested to wait until the end of the show time to tear down.
2. Show participants will be allowed to open the bays near their booths during scheduled set-up time and scheduled tear-down time ONLY. At all other times, bays must remain closed.
3. Show set-up time will be Thursday, March 17 beginning at 5:30 p.m. (no earlier). Site assignments will be emailed prior to event and will be available during set-up time. Please provide an e-mail address on your application. If artists are unable to drop off from 5:30-9 on March 17, please indicate on here: arrangement
4. There is 1 standard booth size: 12' x 9'. Half and double booths are also available.
5. The use of a generator at the Garden Party is allowed, as long as you have a sound barrier and an exhaust filter. Generators will be inspected at the time of arrival and set-up. There will be access to electricity if you select a booth with electricity.
6. Dogbones Network expects participants to carry liability insurance for their own protection. Dogbones Network does carry liability insurance for the event and to fulfill the rental agreement of the facility. Precautions will be made against loss or damage to your booth. It is highly recommended that vendors carry their own insurance.
7. All exhibitors selling merchandise on the Show floor are required to have a business Federal Identification Number or Social Security number if requested by Show Management prior to setting up at the show. The responsibility is yours to comply with state codes for sales tax filing. Vendors must comply with all state and local health, fire and electrical requirements, as applicable.
8. Trash receptacles will be located throughout the show site for the convenience of the participants and may NOT be brought into individual booths.
9. No dogs, cats or other pets are allowed inside the Community Building.
10. The Lane Agri-Park is a no alcohol facility.

Additional Info for Artists: No nudes. As art is subjective, if the organizers deem any submission as inappropriate for all ages or subject matter, pieces will not be hung. The subject is outside, gardens, nature. Nudes, violence, gore and blood are not appropriate for this show. Artists accept the full liability of their pieces.
