The clubhouse may be reserved by residents for use with 25 or less people without a requirement of a deposit. Please use the <u>*Clubhouse Rental Request Form*</u> to request a reservation.

- 1. For groups larger than 25 people, the clubhouse may be reserved for social activities not more than 60 days in advance by individual owners on a first-come, first-served basis. Reservations will be accepted only if the maintenance fees, fine and penalties for the unit are current and upon payment of a \$100 per day Rental Fee and \$250-per-day Cleaning Deposit. Refundable in accordance with reservation set forth herein.
- 2. During holiday weekends, please request the dates at least one week in advance but not more than 60 days in advance.
- 3. All social events must be ended by 10 p.m.
- 4. Owners are responsible for ensuring the facility is cleaned, garbage removed, lights are turned off and the door is securely locked. When the clubhouse is not cleaned after use, owners will be charged a \$250 cleaning fee.
- 5. Management has installed a keyless entry system for the clubhouse and Fitness Center. Each unit is assigned a key card for access to the facility. Management can track the source of vandalism or negligence when it occurs, and owners will be held accountable at their own expense.
- 6. No smoking is permitted.
