#### AGRISCIENCE & ENGINEERING CLASS POLICIES

In order for a class to function effectively, class rules must be followed in order for learning to take place. The following are common for all agriculture classes. THESE RULES ALONG WITH ALL SCHOOL RULES WILL BE FOLLOWED.

#### GHS EXPECTATIONS

- 1. RESPECT- Respect yourself, classmates, teacher, classroom property, and the classroom environment.
- 2. **PRODUCTIVITY** You must focus on assignments, complete all homework and make up work on time.
- 3. **RESPONSIBILITY** Be a responsible scholar at all times. Come to class prepared with pencil, paper, and an attitude ready to learn and work. Follow classroom expectations.

#### ATTENDANCE

Students are required to attend class regularly. After 10 absences, students must appeal for credit. IT IS THE STUDENT'S RESPONSIBILITY TO MAKE UP ALL WORK, INCLUDING TESTS, ASSIGNMENTS, QUIZZES AND LAB ACTIVITIES. Unexcused absences and tardies will result in the loss of possible points for that day's activities. This includes daily points, quizzes, test, laboratory activities and homework. It is your responsibility to get your absences excused.

#### TARDIES

You are tardy if you are not in the classroom at the bell. Students will be assigned lunch detention for tardies. Assignments/quizzes, daily points missed for unexcused tardies cannot be made up.

#### SUPERVISED AGRICULTURAL EXPERIENCE (SAE)

All students enrolled in agriculture are required to have an SAE and to keep records. Records will be checked and part of the class grade. Entries will be made weekly. Those students without an experience will be given out of class projects to meet the SAE requirement.

#### PERSONAL AND SCHOOL PROPERTY

All property and equipment within the department and the school should be treated with care and consideration. Abuse or breakage of property will result in the student replacing or repairing of the item when necessary.

#### GRADING PROCEDURE

Grades will be given using the student's accumulated points divided by the total points possible. The 90-80-70-60% will be used to determine the letter grade. IN ORDER TO RECEIVE A SEMESTER GRADE, THE SAE FINAL REPORT MUST BE TURNED IN ON THE DUE DATE SET BY THE TEACHER. FAILURE TO TURN THIS REPORT IN WILL RESULT IN AN INCOMPLETE GRADE.

#### FINAL EXAMS

Students will not be able to take the final if class/club fees are outstanding and/or class textbooks are not returned. 20% of the final grade will be based upon the final examination

#### LEADERSHIP POINTS

Participation in activities outside of class is highly encouraged to develop the student into an individual possessing stronger skill to compete in the work force. A grade of 50 points will count into the grade every 9 week period. Please refer to the Leadership Points assignment page for further explanation.

#### CLASSROOM EXPECTATIONS

- a. Be courteous to teachers, other students, school personnel, substitute teachers and those who visit the school and agriculture department. Be mature! Loud or abusive language will not be tolerated in the class, halls, or labs. Students are not allowed private conversations during class discussions.
- b. Dress properly for the class activities. Failure to dress properly will result in the loss of the daily points for that day.
- c. No hoodies are allowed on the head during class.
- d. Follow the directions of the teacher and always work in a safe manner.
- e. Teacher permission is required to leave the class for any reason. Failure to do this will result in AFTER SCHOOL DETENTION.
- f. No food or drinks, except water in closed containers, are allowed in the classrooms or labs.
- g. Cell phones must be silenced and not used or seen in the classroom or labs unless used for in class assignments. Teacher permission is necessary for calculator or calendar mode usage. Texting & games are not allowed.
- h. Cellular/ Bluetooth, any digital device (or any other electronic device) are not allowed to be used in the classroom or lab areas, without the teacher's permission. They will be confiscated and turned into the school office
- i. Photo imaging devices are not allowed in the classroom or lab areas without prior approval of the administration and teacher.

#### DISCIPLINE PROCEDURES

- 1. Verbal warning.
- 2. Conference with student.
- 3. Time after / before school in Ag Dept.
- 4. Parental contact.
- 5. Referral to administration.



# Leadership Point System Gilbert High School – Agriscience and Engineering Education Department Quarterly Leadership Assignment

The objective of the assignment is to encourage students to better themselves through active participation in extracurricular activities.

We value the leadership skills and experience gained through participation in organized clubs and organizations. We value participation in extracurricular activities. Students that participate in leadership activities will gain skills necessary for success in life.

The points can come from anything listed on the FFA Point sheet. Although the FFA activities are already in place, it is not the only organization which an individual can gain leadership skills through participation. Points can be earned from most comparable activities from other organizations that match the FFA point system. Examples: Other club meetings, serving on a committee, serving as an officer in another club, teaching a class outside of school, Skills competitions, community service activities (volunteer type activities, i.e. – Adopt-A Highways, serving food at a homeless shelter, etc.)

### Assignment parameters:

- 1. The assignment point total will be 50 points per 9-week grading period.
- 2. Each activity needs to be signed by your agriculture teacher within 2 weeks of the activity date.
- 3. You can only get points for an activity once during the year.
- 4. Your points will not carry over to another 9-week period.
- 5. You can earn up to 25 points extra per 9-week grading period.
- 6. Fundraiser points will be counted only through the FFA.
- 7. You may not split points across 9-week grading periods.
- 8. Sports (once per sport) -50 points.

### **Leadership Points System**

Points are only accepted within 2 weeks of the activity.
