NOTICE IS HEREBY GIVEN THAT THERE WILL BE A **SPRING ELECTION** for **Justice of the Supreme Court, Court of Appeals Judge, District 3, Circuit Court Judge, Branches 5 & 6, and County Executive, along with Shiocton and New London School District members and all Town Officers; Chairperson, 2 Supervisors, Clerk, Treasurer, and Constable and a State referendum** AT THE TOWN HALL LOCATED AT W10388 COUNTY ROAD W ON **TUESDAY, APRIL 7, 2015. THE POLLS WILL OPEN AT 7AM AND CLOSE AT 8PM.**

VOTING BY ABSENTEE BALLOT

Any qualified elector who is unable or unwilling to appear at the polling place on Election Day may request to vote an absentee ballot. A qualified elector is any U.S. citizen, who will be 18 years of age or older on Election Day, and who has resided in the Town for at least 28 consecutive days before the election. **The elector must also be registered to vote in order to receive an absentee ballot. No Photo ID is needed.**

TO OBTAIN AN ABSENTEE BALLOT YOU MUST MAKE A REQUEST IN WRITING

Contact your municipal clerk and request that an application for an absentee ballot be sent to you for the primary or election or both. You may also request an absentee ballot by letter. Your written request must list your voting address within the municipality where you wish to vote, the address where the absentee ballot should be sent, if different, and your signature. Special absentee voting application provisions apply to electors who are indefinitely confined to home or a care facility, in the military, hospitalized, or serving as a sequestered juror. If this applies to you, contact the municipal clerk. You can also personally go to the clerk's office, complete a written application, and vote an absentee ballot during the hours specified below.

Absentee ballots can be completed by mail or in person at the town hall. Please contact the clerk to set up a time to meet her at the town hall. Posted hours for absentee voting by appointment are Mondays 9am to 7pm and Tuesday through Friday 5:30pm to 7pm.

DEADLINES

The deadline for making application to ***request absentee ballots (except by military and indefinitely confined electors) by mail*** is 5:00PM on Thursday, April 2, 2015.

The ***first day to vote an absentee ballot in the clerk's office*** is Monday, March 23, 2015. The deadline ***to vote absentee in person in the clerk's office*** is 5:00PM on Friday, April 3, 2015.

The Clerk will deliver absentee voted ballots returned on or before Election Day to the polling place before the polls close on April 7, 2015. Any ballots received after the polls close will be counted by the Board of Canvassers if postmarked by Election Day and received no later than 4:00 pm on the Friday following the Election.
