On November 11, news agencies reported that the White House will extend the Covid-19 public health emergency to April 2023. But even so, Americans should start preparing for a new reality: **Free Covid tests may soon be a thing of the past.** Throughout the pandemic, the federal government purchased vaccines, treatments and tests to provide them to the general public for free. The White House's recent requests for more Covid-19 funding have largely fallen flat with lawmakers. Without more funding, the free and reimbursed Covid testing options will end.

It was always the plan to transition Covid-19 costs from the federal government to the private market. But the lack of funding is accelerating the transition—and will likely lead to sticker shock for consumers, especially for those who are uninsured. There will no longer be a requirement for insurers to reimburse Americans for at-home Covid tests. PCR tests may require a prescription or physician's order.

It's hard to predict exactly how much tests and treatments may cost, but consumers still have opportunities now to ease the burden of cost-sharing once the public health emergency ends. Consumers can still get the costs of up to eight at-home Covid tests covered by your private insurer each month. If you're worried about your Covid tests expiring before you can use them, there's good news: Many at-home test kits have been granted extended expiration dates by the FDA which says they're still fine to use even after the listed expiration date. For example, the FDA has extended the shelf life of BinaxNOW Covid-19 antigen self-tests from 12 to 15 months.

Even though the public's uninsured rate is at the lowest in history, there are still millions of Americans who don't have health insurance. They stand to be the most vulnerable to test costs once Covid-19 testing and treatment gets commercialized. The Inflation Reduction Act extended subsidies for Affordable Care Act marketplace health insurance premiums through 2025. People with annual incomes below 150% of the federal poverty limit (\$20,385 for an individual and \$27,465 for a couple) are eligible for a \$0 premium, depending on the plan they select.

To parents and grandparents of Auxiliary and SAL junior members!

Please remember that when your child reaches age 18 they automatically become senior members of our Post and will then need to pay adult yearly dues (Auxiliary \$40, SAL \$30). Example: Juniors born on or AFTER Jan 1, 2005 are junior members for 2023. Juniors born on or BEFORE Jan 1, 2005 are considered senior members for 2023, and will be asked to pay adult dues.



Please remember that the Legion & Auxiliary Dept of MI HQ regularly sends out duplicate dues renewal notices to members. If you have paid your 2023 dues and have your new membership card PLEASE ignore these notices, DO NOT send another payment, you are all set for 2023!

As a Veteran, you may be eligible for certain tax benefits.

It's important to file your taxes before this year's **April 18 deadline** and be aware of the benefits that apply to you. Here's a summary of some of the key tax benefits for military veterans. And don't forget: Tax advice that applies to civilians can benefit you too.

Federal Taxes

- Military retirement pay is taxable as federal income and is not considered earned income for Social Security tax purposes.

- Premiums for the Survivor Benefit Plan are excluded from taxable income.

- Veterans education benefit payments received through VA for education and training are tax-free.

- Disability benefits received from VA, such as disability compensation, pension payments and grants for home modifications, are not taxable.

- Money from VA that is not taxed: Interest from VA life insurance policies. Benefits under a dependent-care assistance program. Money paid to a survivor of a member of the armed forces who died after Sept. 10, 2001. Payments made under the compensated work therapy program.

- Note that if you had a recent increase in your disability rating or were granted combat-related special compensation, you may be eligible for a tax refund, but this can only be applied to the year VA reassessed your disability level.

- AARP Foundation's Tax-Aide program

https://taxaide.aarpfoundation.org/ offers free tax help to anyone, with a focus on taxpayers who are 50 and older and have low to moderate incomes. Tax assistance is available through knowledgeable volunteers, either inperson or virtually, by appointment only.

State Taxes

- States typically offer tax benefits only to veterans who were honorably discharged or released from active duty under honorable circumstances.

- Benefits are often transferred to a spouse or surviving spouse of honorably discharged veterans.

- Military retirement pay may be taxed differently in different states.

- Disabled veterans can qualify for property tax exemptions at the state level. These breaks, which are usually tied to a specific disability rating, can help a veteran save thousands of dollars. You can view a list of all property tax exemptions by state and disability percentage here.

Social Security COLA Fraud

Social Security payments boosted by the biggest costof-living adjustment (COLA) in more than 40 years start going out soon, and beneficiaries aren't the only ones looking forward with anticipation. Scammers who impersonate Social Security Administration (SSA) officials in robocalls, text messages, letters, emails and even fake websites are adapting their pitches, claiming targets have to pay a fee or provide personal or financial data to get their benefits increase. Scammers can easily make communications look authentic. Please remember COLA increases are automatic, and **do not require recipients to take ANY action.**

2023 Fraud Update

Please be suspicious if you receive a letter or email from someone who claims to have the same name as you, is dying and wants to give you their estate. This is most certainly a fraud. If you went through with it, there would be some sort of "good faith" fee or payment for transfer, which they would take and then either disappear or keep pressing you for more money.

Be on the lookout for anyone calling (or emailing) you claiming to be from your utility company threatening to turn off power if you don't pay up. Utility companies WILL NOT contact you this way. They will notify you by mail if you are overdue on payments. Often, during winter months, storms or extreme temperatures, criminals will pose as utilities to try and scare people into sending money.

When you need to get in touch with your bank or credit card company (or even major retailers like Amazon for a refund, etc) you might go online to look up a phone number to contact customer service. A new trend for criminals is to place fake customer service numbers online to trick people into calling (some even rank high in Google searches). Always go directly to the company's website, or look on your account statement or the back of your bank or credit card for real contact information.

NEVER, EVER send payments to ANY company or service that insists on being paid with gift cards (also cryptocurrency or wire transfer). NO legitimate company does business this way. PERIOD!

Thinking of going back to school, pursuing a trade or training for a better job? Not everyone strives for a degree or attends a trade school right after high school. If you are a Legion Family member, you may qualify for a \$2,000 **Non-Traditional Student Scholarship** available from the American Legion Auxiliary. This scholarship is open to all ages for those pursuing training in a certified, trade, professional, or technical program, or a two-year or four-year degree program. Membership Eligibility



Legion membership eligibility. Veterans or active duty military who have served at least one day of active duty in the US Armed Forces since December 7, 1941 and have been honorably discharged or are still serving. Must present a DD-214 (DD-217, DD-256, or DD-257).

Auxiliary membership eligibility. 1) Relationship to veteran: Grandmother, mother, sister, daughter, granddaughter, male or female spouse, or self (for female veterans). Per IRS regulations, step-relatives are not eligible. The IRS only allows two degrees of a blood line, so <u>great</u> granddaughters and beyond are not eligible. 2) Potential member must be related to a *living* veteran by one of the relationships stated **AND** veteran is a current member of the American Legion. **OR**, potential member is related to a *deceased* veteran who served at least one day of active service during eligible time periods (Apr. 6, 1917 to Nov. 11, 1918 and any time after Dec. 7, 1941) and was honorably discharged. Deceased veteran does not have to have been a member of the American Legion.

SAL membership eligibility. 1) All male descendants adopted sons, and stepsons. 2) Potential member must be related to a *living* veteran by one of the relationships stated **AND** veteran is a current member of the American Legion. **OR**, potential member is related to a *deceased* veteran who served at least one day of active service during eligible time periods (Apr. 6, 1917 to Nov. 11, 1918 and any time after Dec. 7, 1941) and was honorably discharged. Deceased veteran does not have to have been a member of the American Legion.
