- 2) Santa's Closet delivers the gifts requested through the Sleighbells Program.
- 3) **Every Fifteen Minutes** is a program aimed at keeping our youth off drugs and alcohol.

Rick is looking for volunteers to help co-ordinate participation and assistance with these programs within our fire service community. They have a monthly meeting. Rhet Howard was mentioned as a possible candidate as our fire service representative as he is already serving on MCPAL board.

Rick noted that MCPAL has a bicycle event in the offing and will need a brush unit and medical personnel to assist with the effort. They are also sponsoring a fire arms safety class (not relating to hunting safety fire arms classes.)

Jeff discussed the possibility of extending the county-wide burn ban through the end of October 2015. This proposal was supported by the membership so Jeff will execute the necessary paperwork to extend the burn ban through 31 October and carry it to the County Commissioners for action.

Jeff handed out copies of the Everbridge Emergency Notification System signup flyers for us to hand out in our respective communities.

Chuck Virts from KCFD3 handed out a flyer announcing the availability of a Weapons of Mass Destruction class being held 26 Sep. 2015 from 0800 – 1700 at KCFD3 Sta. 31 in Husum. The class is free and lunch will be provided. See the attached class announcement flyer.
