Minutes for 2016 Annual Membership Meeting & Banquet

President Albert Reyna welcomed members and guests to the 25th Anniversary Celebration, recognized the Silver Committee of Edie Bartos Canale, Bobby DeLeon and Mark Stutler for their efforts in planning and arranging the celebration. He also recognized the two Anniversary Sponsors, Jain Irrigation and Aluminum Metal Products.

Following a prayer by Mark Stutler, a German buffet was served by My Own Chef Caterers.

After the meal Bobby De Leon introduced the speaker for the evening, John Farner of the Irrigation Association. He outlined some of the different positions on ag issues of the two presidential candidates, Clinton and Trump. John reviewed the freshwater availability on a world basis and the various facets of water use. He noted that due to increasing world population the cropland per person is steadily declining, currently less than 0.2 ha (about 0.5 acre) per person.

John pointed out the importance of irrigated agriculture in Texas, being third in the US in terms of irrigated acres. He said that the IA's mission is to promote efficient irrigation and its vision is to be the recognized authority on irrigation. IA is attempting to do that through core strategic initiatives, one of which is professional development through education, training and certification. (TAIA is a member of the IA.)

John finished up by talking about the IA show to be held this year in Las Vegas in conjunction with Groundwater Week. He also introduced a brand new magazine entitled *Irrigation Today*.
