D. Consider and Discuss Resolution No. 2023-05-22-01

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CISCO, TEXAS, ("APPLICANT"), APPROVING APPLICATION TO THE TEXAS PARKS AND WILDLIFE DEPARTMENT ("DEPARTMENT") FOR THE LOCAL PARK GRANT PROGRAM ("PROGRAM"); AND DESIGNATING CERTAIN OFFICIALS AS BEING RESPONSIBLE FOR ACTING ON BEHALF OF THE APPLICANT IN DEALING WITH THE DEPARTMENT IN REGARD TO THE PROGRAM.

Mr. Archer again spoke saying that the proposed resolution would be to apply for a \$750,000.00 park grant from the Texas Parks & Wildlife Department for Project Function Junction. He said that the grant is a one to one match meaning the city would match every dollar awarded. He has already received a verbal commitment from the public/private partnership involved in that project to help with matching funds.
