The Future of the ILR

The majority of the most recent board meeting concerned the future of the ILR in these uncertain times. Options were discussed in detail, including proceeding with an in-person semester, holding an online class semester, or canceling the semester. The pros of an online semester, including the ability to have unlimited course registrations per member;

and the cons of in-person classes, primarily being the difficulty with cleaning and sanitizing, were analyzed and noted.

The board felt that an online semester may be the best course of action and proceeded to poll the instructors as to whether they were willing to teach via an online platform like Zoom Meeting. Twothirds of the instructors are willing. Therefore, the board will move forward with polling the membership with an online survey that will be forthcoming by email, also. If there is enough interest, the ILR will be holding practice class sessions through Zoom over the summer where members can learn the technology, have their questions answered, and work out the bugs. Written and video instructions would also be provided. Conversely, if there is not enough interest, then the semester will be canceled. Please keep your Spring 2020 catalog for now.
