## LITERACY ACCESS FUND ANNOUNCES 2019 GRANT AWARD TO THE MONTGOMERY COUNTY-NORRISTOWN PUBLIC LIBRARY

CHESTER, PA - Literacy Access Fund, a 501 (c) (3), public charity, announces a grant award of \$7,770 to the Montgomery County-Norristown Public Library in Norristown, Montgomery County, Pennsylvania. Literacy Access Fund secures funding from corporate, foundation, and individual partners in order to provide financial support to underfunded public libraries through a competitive granting process. The goal of the organization is to help libraries provide equal access to quality resources for young learners, regardless of economic factors.

The award was made possible through partnership funding from Bryn Mawr Trust, headquartered in Bryn Mawr, PA. The grant will help fund the acquisition of state-of-the-art technology for young children and other library resources.

Kelly Isett, President of the Montgomery County-Norristown Public Library's Board of Directors, noted the Board's gratitude to Literacy Access Fund for the award. "It amazes me to see the wide range of programs, services, and activities that this library offers every day. This grant will provide our young patrons access to technology education that they might not otherwise obtain. We are grateful for this support."
