TREASURER'S REPORT:

CATFISH BEND CASINOS L.C. REPORT:

Rob Higgins indicated that the casino had a fabulous year in 2015. He made the point that even though revenues have gone down this year they are still up from 2014. Rob handed out a copy of the casino's newest free play Sunday promotion to the board. He informed the board that the payback of the casino has been consistent, and in fact is third in the state. He indicated that December's entertainment is going to be the Oak Ridge Boys which expects to be a very good draw.

Mr. Higgins went on to discuss that they are staring renovations for their new rental Panera and owner Coldstone. He also discussed the plans for the new 86 room Hampton Inn Suites which will be going up with opening expected next year. New renovations are also taking place in the waterpark, with the addition of a new slide and some other amenities.

Other Business:

Steven Staebell reminded the board that election of officers takes place at the January meeting and the importance of being present

Discussion was had on the reports to the IGA which wants our information by the 21st of this month. Want to highlight our expenditures and to advise everyone of how the grant money is spent. The report is included in the license report.

Regarding the SIRRC Governance Report the state has approved and removed term limits due to the special nature of our organization being a pass through type entity.

A motion was made by Chuck Kempker to approve CPA Associates for the SIRRC audit. The motion was seconded by Terry Johnson and passed on unanimous vote.

A discussion was had concerning the IGA conference call. A request for timely financial report was made. The smoking issue has been brought up, however, it doesn't appear that will go forward. Other casinos along the river have been having reduced revenues which have been attributed to Illinois video poker in bars. Rob Higgins indicates that Catfish Bend has not seen this loss of revenue and he opined that it may be the result of a difference between a bar patron and a casino patron.
