# **Meeting Minutes**

**Secretary Report**: Linda Hothan summarized business since the last Board meeting:

- 5 new members voted into NERRC via email in February: Julie and Brandon Paul, Rachel Reams, Holly Oliver, and Jeff Trombetta. The Secretary will retain applications for the Club files.

SB458 - Sen. Montigny, Mark (D) - An Act relative to privately operated animal shelters and rescue organizations. Action: 02/20/18 - Accompanied study order.

## Canine Cryptorchidism - Undescended testicles in dogs

Basic research on canine cryptorchidism defines the complications as a "common developmental defect in purebred dogs causes health concerns of reduced fertility and increases risk of testicular malignancies" (Zhao, et al, 2010). Dogs who go on to attempt breeding have been found to have reduced sperm count or be completely infertile. Dogs who retain the undescended testicle are the most at risk, obviously, for the cancers associated with this issue. (Zhao, et al, 2009)

So far, 21 genes have been associated with the abnormality, and it is an autosomal recessive gene. This means that it is not on the sex chromosomes, but on the normal body-type chromosomes. Recessive means that generally speaking, it is the most likely to appear in a dog with lineage of both sides containing the gene. In reference for breeding, if both the dog and the bitch carry the gene, the dog will have the trait (Lopate, C., 2011). Given that the gene for cryptorchidism is not a single loci gene, it has been shown to be inherited with several other disorders such as hip dysplasia, patellar luxation, and penile issues. The breeds studied so far have been "Boxer, English Bulldog, Cairn terrier, Chihuahua, Miniature Dachshund, Maltese, Pekingese, Pomeranian, Toy, Miniature and Standard Poodle, Miniature Schnauzer, Old English Sheepdog, Shetland Sheepdog, Siberian Husky, and Yorkshire Terrier" (Lopate, C., 2011). These breeds all show the autosomal recessive pattern mentioned above. Obviously, the Bergamasco Sheepdog has not been studied or submitted sufficient DNA samples to anyone for sufficient study on any abnormality so far.

For anyone not aware of the basic anatomy and developmental issues here, this is the basic progression. Normal testicular development involves a series of steps wherein the the testes descend down from an area near the kidneys, through the abdomen, and eventually through the groin. Failure to descend properly at any of these steps is directly related to a genetic mutation so that the testes do not progress through the steps properly. Depending on where the testes are held up in descent can dictate the severity of the result for the animal. The process begins prior to birth and is finished for dogs by day 14-35. Hormones are not a contributing factor, although they were once thought to be significant. By the end of 8 weeks, if the dog does not have both descended testicles, he is considered crytorchorchid. The right testes is more common than the

left, because of where it begins in its journey down the pathway. Hormone treatments or other methods are not successful in treatment of this genetic mutation abnormality.

## According to this geneticist,

"Removal of all affected males, their offspring and their parents from the breeding program is the recommended course. Waiting until puberty is fully attained is recommended before deeming any individual a cryptorchid." (Lopate, C., 2011).

## According to 2 veterinarians,

"Cryptorchid dogs should never be bred." (Ward, E., & Downing, R., 2018)

The reasons for this recommendation are based on the hundreds of studies done on this topic since 2009. Our genetic study abilities changed dramatically since then, because we have the ability to isolate unique SNPs - single nucleotide polymorphisms, variations between genes. This allows us to examine traits such as cryptorchidism in ways that were not possible prior to the canine genome being mapped and SNPs coming into play for breeds. Just since 2012, this mutation has been studied sufficiently to lead to all the breeds mentioned above being studied enough for us to understand this condition as an autosomal recessive disease. Not to say that it might be. We are able to say unequivocally that it is autosomal recessive. This means we can probably map this on our pedigrees fairly easily now. Even a simple google inquiry, "Should you breed a dog with cryptorchidism?" will lead you to hundreds of simple results explaining the above without too much scientific jargon.

We can certainly obtain and study our Bergamasco Sheepdog DNA and compare it to the studies that have been done, which would be a great service to the breed. Mapping the Bergamasco Sheepdog genome will only lead to greater understanding overall of all the possibilities of linked and not linked disorders. For breeding programs, why wouldn't we want to breed our healthiest, mutation-free dogs.
