ENTRIES

1. Forms and fees (\$2.50 per animal) for Pigeons must be received by **July 28, 2016**. **NO EXCEPTIONS!**
2. One four-day parking pass will be issued with a minimum of 10 small stock entries. If less than 10 entries – discounted parking passes can be purchased for \$10 for a weekly pass.
3. Send all entries to: Salt Lake County Fair, Attn: Pigeons 2100 West 11400 South, South Jordan, UT 84095
4. Entry forms must include the following information: Breed-Variety and Color – whether Old Cock, Old Hen, or Young Cock, Young Hen – Band Number

PLACING & RELEASE OF EXHIBITS

Check - In : Tuesday, August 1, 2017 - 6:00 pm - 9:00 pm

Check - Out: Saturday, August 5, 2017 – 10:00 pm **NO EXCEPTIONS** - Animals must be left on display for the duration of the show which is a total of five days.

Birds sold will not be released until 10:00 pm Saturday night, August 5th.

JUDGING SCHEDULE

1. Judging will take place Wednesday, August 2nd starting at 9:00 am
2. Judge TBA
3. Conversation with the judge is prohibited during judging, except with show management. A violation of this rule disqualifies the exhibitor's animal.
4. The judge's decision will be final.



MISCELLANEOUS

1. The show or Salt Lake County Fair is not responsible for any damage, accident or death while exhibit is at the Fair Grounds.
2. Each specimen must be the bona fide property of the exhibitor and shown in its natural condition.
3. All entries must have permanent band numbers located on the leg.
4. There will be no communication with the judge during or prior to judging. This will result in disqualification.

AWARDS

Salt Lake County Fair awards the following:

1. Plaques/Trophies for Best in Show, Reserve Champion, Second Reserve and place ribbons in 1st, 2nd, and 3rd place.
2. Rosettes will be awarded to the 5 Largest Breeds not qualifying for a plaque.

PREMIUMS

1. Salt Lake County Fair pays the following cash awards for entries in each lot on pigeons.
 - 1st - \$3.00
 - 2nd - \$2.00
 - 3rd - \$1.00

SALE OF BIRDS

1. **“For Sale”** signs placed on cages may not be any larger than a 3” x 5” card. Cards must be typed or printed neatly.
2. Only birds entered in the show may be offered for sale
3. Birds sold will not be released until 10:00 pm on Saturday, August 5, 2017.
“For Sale” signs may not be put up until judging is completed
