Dear Members of District 2 AA,

I hope this message finds you well. I wanted to take a moment to reflect on the events that took place in March. I hope everyone had a wonderful Easter celebration with their loved ones, filled with joy and lots of good food.

As you may know, last month, I had the pleasure of attending the spring Pre-General Service Assembly in Mission, TX, along with 14 members of District 2. The conference was hosted by District 10 and the theme was Connecting with Love, Unity, and Service. I want to thank everyone who made the effort to attend the conference.

During the conference, we discussed two <u>proposed</u> agenda items from a member of District 3B, the founder's writings surveys, and approved agenda items for the upcoming 2024 general service conference. The sense of the area (outcomes of the discussions) is noted:

Proposed Agenda Items for 2025 GSC

- 1.Consider changes to the GSB that 3 of 7 Class A Trustee positions transition to Class B. -39 For / 109 Against
- 2.Consider changes to the voting members of the GSC (removing non-trustees & GSO staff).- 79 For / 71 Against

Note that items for the 2025 General Service Conference are more like an endorsement as they will be submitted with or without Area support.

Approved Agenda Items for April 2024 GSC

- 1. Request to develop a pamphlet on the unhoused alcoholic in A.A.- 83 For/ 63 Against
- 2.Review progress report (survey) from fellowship on potential future changes to AA Founder's writings. The majority in attendance were against any changes.
- 3. Plain and Simple language big book- For 10/139 Against
- 4. Equitable distribution of workload process- The majority in attendance were supportive of spreading the workload amongst the committees.
- 5.Cost-effectiveness of continuing to PRINT La Vina. -Lots of discussion and some recommendations. The sense of the group is to continue to print but find a way to fund it.
- 6.Explore all the services provided by Grapevine and how should be funded. Lots of discussion, and no proposals from this meeting but all agreed something needs to be done.

In addition to the conference, I also had the opportunity to attend two meetings and a group event with our district. A Woman's Way to AA which is held on Friday mornings at 10:30 am in New Braunfels, the Solutions Group in Canyon Lake on Mondays at 6:30 pm, as well as the Canyon Lake Groups campout held the weekend of March 22nd-24th. The campout was a great, well-attended event, and I want to thank all those involved in organizing it.

"Made a searching and fearless moral inventory of ourselves."

THE ONE THING I NEED TO KNOW ABOUT STEP 4:

It's About Causes & Conditions

Principle of this Step: Courage

What Can I Surrender in this Step?

1. Fear of looking at who I was, and 2. Any desire to regret the past

STEP SUMMARY

Page 64 in the Big Book starts by comparing a personal inventory to a business inventory. In the first full paragraph of page 64, it says "Therefore, we started upon a personal inventory. A business which takes no regular inventory usually goes broke. Taking a commercial inventory is a fact-finding and a fact-facing process. It is an effort to discover the truth about the stock-in-trade. One object is to disclose damaged or unsalable goods, to get rid of them promptly and without regret.

The whole point of a business inventory is to identify a company's **liabilities** and its **assets**. They identify their liabilities (those things that are no longer selling- or working for them) so they can remove them from the shelves to make room for more assets (those things that will sell or work for them). Taking a personal inventory is no different. We searched out the flaws in our make-up which caused our failure. Being convinced that self (not alcohol but self), manifested in various ways, was what had defeated us, we confused its common manifestations. We had to get down to **causes** and **conditions**.

TRADITION 4

Short Form: "Each group should be autonomous except in matters affecting other groups of AA as a whole.

Long-form: "With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.

Overriding Idea of T4: Our Decisions Affect Others

CONCEPT 4

Short Form: "At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.

Long Form: "Throughout our Conference structure, we ought to maintain at all responsible levels a traditional "Right of Participation," taking care that each classification or group of our world servants shall be allowed a voting representation in reasonable proportion to the responsibility that each must discharge."
