## By submitting your application and payment you are agreeing to abide by all rules, policies and procedures printed and incorporated in this application/contract.

- *NEW* All special requests must be submitted at least 30 days before the event to be reviewed by the committee for approval or denial of request. No changes will be allowed the day of the event.
- *You will receive email notification when your application has been accepted*. There will be no follow up emails unless there are event changes that affect the vendors.
- All submissions will be reviewed for event approval. Upon review you will be contacted and notified if your submission was accepted for this event. You will then have 5 days to submit your payment. Failure to submit payment in a timely manner may result in your space being forfeited to next on waiting list. Our goal is to provide a variety of different vendors for event goers and will do our best to encourage diversity in different business categories. We are anticipating a large turn-out and may need to limit vendors in the same business category to make it a successful event.
- Setup times will be from 8 am 10:15 am.
- You will have **one** 8ft table available for your goods. Vendor spacing, with table, is approximately 8'x5'
- You must remain set up until 4 pm (or later if you still have customers). Failure to comply will result in loss of future participation privileges.
- The Dodgeville Area Chamber of Commerce reserves the right to refuse to any contract for a Vendor at this event for any reason.
- All Vendors are responsible for reporting their earnings from this event according to State & Federal regulations.
- You must leave the space you rented in the clean condition that you found it in. No garbage is to be left behind.

Payments may be made by check or credit card (includes 3.5% processing fee) within 5 days of your acceptance to the event or the vendor space will be forfeited.
