May 2014 Dust Off Cruise Report

Ten vehicles (five Firebirds, three '64-67 A-bodies, and two SUVs) carrying 19 people showed up early May 17th at the Elhart campus in Holland for our annual spring dust off cruise. The weather was a bit cool for the time of year, but that has been the norm since winter and into the spring. The caravan left promptly at 8:30 AM and we headed down US 31 turning onto the Blue Star Highway, and then onto M140 just south of South Haven.

The towns we drove through included Saugatuck, Douglas, Ganges, Glenn, South Haven, Covert, Watervliet, and Sister Lakes. Our ultimate destination was Sun Ray Restorations, which was located just east of Sister Lakes, but has a Dowagiac address.

Bill Godisak, owner of Sun Ray, gave us a tour of his fine establishment. Bill and his crew specialize in Packard restorations. He had one in the shop completely torn down to the body tub, and a chassis for another car that had been painted a beautiful glossy royal blue and was in the early stages of being reassembled. The Ralston aluminum body was in a trailer waiting to come into the shop for its restoration. The ultimate goal for this particular car is Best of Show at Pebble Beach! From the looks of the chassis, I'm pretty confident that the car will be a contender!

Also in the shop was a 1931 Marmon V-16 roadster! It was a good looking car with grey paint and black top and interior. What really stood out about the car to me was its massive 490 cubic inch, all aluminum V16 engine! It makes 200 horsepower, which was very powerful for the early 1930s. There was also a late-twenties or early thirties Paige automobile. Both the Marmon and Paige weren't restored at Sun Ray, but the owners wanted them "corrected" and "made right" by Bill and his employees.

Bill and his wife also shared with us their personal car collections which included an early '50s Jaguar roadster, a custom '50s pickup, '66 427 Corvette, '70 SS 454 Chevelle, a Packard V8 powered '20s pickup (made from leftover parts from other projects), an early '30s Ford pickup destined someday for Bonneville, a 1960-ish Corvette drag car (Bill's first car?), and a beautifully restored early '30s Packard sedan.

I could have stayed there much longer and talk to Bill, his wife, and Jordan, one of the employees. But we had to be back in South Haven to have lunch at Clementine's. So we jumped back into our cars and made the trip back north. We pulled into South Haven around 1 PM, and we were on our own to find parking near the restaurant. Phoenix Street, the main drag through downtown


South Haven, was still closed (from being completely rebuilt), but the crews were putting the finishing touches on it still. Even so, parking wasn't hard to find. Clementine's had two adjacent tables set up for us, and we were seated right away. The food and service were excellent!

After our dinner, the ladies did some shopping and then we all gathered at the Meijers gas station just east of town to headed north to see Scott and Michelle Van Tamelen's property and Trans Am Anniversary collection. When we arrived, all of Scott's and Michelle's Firebirds were outside the barn and arranged in order, including a 1984 (15th Anniversary), 1989 (20th Anniversary), and a 1994 (25th Anniversary). Scott hopes to find a 1979 silver 10th Anniversary and a 1999 30th Anniversary in the future to complete their collection.
