

Cancellation Policy

Your payment holds a space in the camp/class in which you are registering. If you cannot attend your camp or class, please let us know and we will work with you to secure another appropriate camp/class within one year of your original registration date. If you cancel before 14 days of the first day of camp/class, then your full payment amount will be refunded. If you cancel within 14 days of the first day of camp/class, then 1/2 of the payment will be forfeited. We do not provide make-ups for some camps or workshops. We are willing to provide up to two make-ups for our 8 week workshops and up to one make-up for our 4 week workshops, but all make-ups must be scheduled and occur within 2 weeks from which the semester ended.

Release, Waiver and Indemnity

Releasing Parties individually and on behalf of their heirs, executors, administrators, personal representatives, successors and assigns FULLY RELEASE, DISCHARGE, WAIVE and COVENANT NOT TO SUE BOT Spot Corp. (dba BOT Spot) and their respective agents, employees, officers, directors, representatives, successors, assigns, affiliates, subsidiaries, members, and volunteers, as well as any and all participants, officials, referees, coaches, host clubs, sponsoring agencies, sponsors, advertisers, and local organizing committees of any sanctioned or unsanctioned class, camp, event, league play, practice, scrimmage(s) or activity ("Robotics Activity" or "Robotics Activities") and, if applicable, the owners, lessors, lessees, and operators of any premises used to conduct any Robotics Activity and any property or equipment used at an Robotics Activity (all hereinafter "Released Parties") from any and all loss, injury, liability, claim, cause of action, or damage to person or property (including, without limitation damages for personal injury, death, survival damages, disfigurement, disability, paralysis, mental anguish, and property damage), whether existing now or arising in the future, arising out of or related to a Releasing Parties' participation in, attendance at, preparation for, or traveling to or from an Robotics Activity, including loss or damages caused by the SOLE OR PARTIAL NEGLIGENCE of Released Parties ("Released Claims"). Releasing Parties agree that this release and the term Released Claim as used herein shall be construed as broad as possible and include all legal or equitable claims and causes of action of any nature whether arising in negligence, representation, premises liability, strict liability, contract, warranty, tort, or by statute or otherwise. Releasing parties shall INDEMNIFY, DEFEND AND HOLD HARMLESS the Released Parties from any and all claims, causes of action, liabilities and damages arising out of or related to any Released Claim, including without limitation, claims, causes of action, liabilities and damages CAUSED OR ALLEGED TO BE CAUSED BY THE SOLE, CONCURRENT OR PARTIAL NEGLIGENCE OR OTHER ACTS OR OMMISSIONS OF ANY RELEASED PARTY.

Acknowledgement and Assumption of Risk

Releasing Parties understand and acknowledge that Robotics Activities have inherent risks and dangers that no amount of care, caution, training, instruction, supervision or expertise can eliminate. Each participant at any Robotics Activity, including Participant, will be engaging in activities that involve risk of serious injury, including permanent, temporary, total or partial disability, disfigurement, paralysis, death and any other losses to person or property. Injuries or losses may result not only from a Releasing Parties' own actions, inactions or negligence, but also from actions, inactions or negligence of others (notwithstanding the rules of play) or conditions of the premises or of any equipment used. Coaches, referees, officials, volunteers, participants and others at Robotics Activities are not trained medical doctors and may not be capable of administering emergency treatment in case of injury. Further, Releasing Parties acknowledge and fully understand that there may be other associated risks with such activities, which are not known or not reasonably foreseeable at this time. Releasing Parties assume all risks and liabilities arising out of or related to attendance at or participation in an Robotics Activity (including risks of traveling to or from the Robotics Activity), including risk of personal injury, mental anguish, death, total or partial, temporary or permanent disfigurement, disability or paralysis, and any other losses, injury or damage to person or property.

Release and Authorization to Use Photos and Likeness

Releasing Parties also release and authorize the Released Parties to publish and use the Releasing Parties' photographs taken during or in connection with Robotics Activities, names and likeness in news articles, web sites and other news or advertising media.

Understanding, Termination and Governing Law

Releasing Parties acknowledge that they have fully read and understood this agreement and execute the same of their own free will. Releasing Parties further acknowledge and agree that their promises and agreements contained in this agreement are material to the Released Parties and that without such promises and agreements Participant would not be allowed to participate in Robotics Activities with BOT Spot Corp. (dba BOT Spot). This Release and Waiver may not be terminated or waived as long as Participant attends or participates in Robotics Activities. This Release, Waiver and Indemnity may not be terminated or waived except by written agreement signed by Participant, Parent or Guardian of Participant and an authorized representative of BOT Spot Corp. (dba BOT Spot). If Participant is under age eighteen (18), this Release and Waiver is effective if executed solely by Participant's Parent or Guardian. This Release and Waiver shall be construed according to the laws of the State of Illinoiswithout regarding to its conflicts of laws provisions. It any part of this Release, Waiver and Indemnity is deemed invalid, the remaining parts will remain fully enforceable. This Release, Waiver and Indemnity shall be construed to the full extent allowed by law.

Medical Emergencies

In the event of an emergency, we will attempt to contact you or your emergency contact provided on your registration. In the event that someone may not be reached, your child will be taken to the most appropriate emergency facility and will be accompanied by our staff, but will not be held financially responsible for transportation or medical services. I hearby release the staff and instructions from all responsibility in the event of an accident.

Sick Policy

We are committed to maintaining the good health of the center as much as possible. We have many hands-on activities which means contact with laptops, LEGOs and other equipment. To help in the cleanliness of this equipment we ask that you cooperate in this effort. When children have any of the following conditions they may not stay at center: Temperature of 101 or higher; Vomiting; Diarrhea - 2 or 3 loose stools in a short time; Two or more cold symptoms; Undiagnosed rash on the body***, Cloudy discharge from the eye(s) *** or any communicable disease *** (***A doctor's note must be presented upon return to the office when a child is sent home from a class or camp with these symptoms.) We require that children not return to the center until symptoms have been gone for 24 hours. Children who are sick will be isolated. Remember isolation is a temporary situation, and the child must be picked up immediately. Failure to comply with the Sick Policy and dropping a child off with these conditions will result in no refund for the days the child misses and the child will be sent home. If we are contacted about the illness by voicemail or email to mybotspot1@gmail.com within 24 hours before the start of a class we will work with you to reschedule the class, transfer to a camp another week or provide a refund for half of the amount that the child is unable to attend.
